SELECTION CRITERIA, TERMS & OTHER CONDITIONS

01: Name of the Position: Staff Nurse

<u>Eligibility Criteria:</u> In order to be eligible for direct recruitment to the post of Staff Nurse, a candidate shall have to satisfy the following conditions, namely-

Nationality- S/he must be a citizen of India.

Age limit- S/he must have attained the age of 21 years and must not be above the age of 32 years as on 01.12.2018 except ASHAs those who have completed 1 year in the health system in the State and below the age of 45 years. S/he shall be allowed to take part in the recruitment process if having the minimum qualification as required for SN. However, age relaxation & reservation policy of State Govt. is to be followed in Toto, for candidates fulfilling criteria prescribed in the said policy.

Knowledge in Odia- The candidates must:

- a) Be able to read, write and speak Odia;
- b) Have passed middle school examination with Odia as language subject; or
- c) Have passed matriculation or equivalent examination with Odia as medium of examination in non-language subject; or
- d) Have passed in Odia as language subject in the final examination of class VII from a school or educational institution recognized by the Government of Odisha or the Central Government; or
- e) Have passed a test in Odia in Middle English School standard conducted by School & Mass Education Department.

Marital Status- If married, the candidate must not have more than one spouse living:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person or there are other specific grounds for doing so, exempt any person from the operation of this rule.

<u>Minimum Educational Qualification</u>- The candidates must have passed in General Nursing & Midwife/B.Sc. Nursing from any 3 Govt. Nursing schools of 3 medical college/school of nursing MCL Talcher/IGH Rourkela or other recognized private institutions duly approved by INC and must have registered in the Odisha Nursing Council (ONC).

<u>Physical Fitness</u>- The candidate must be good mental and physical health and free from any physical defects likely make her incapable of discharging her normal duties in the service. A candidate, who after such medical examination as the Government may prescribe is not found to satisfy the requirements shall not be appointed to the service.

<u>Registration</u>- The candidates must have registered her name in Nursing Council in the state and have possessed valid registration certificates as on the date of advertisement.


<u>Additional Marks for ASHAs</u> ASHAs shall be allowed one percent extra mark of the total marks for each completed year of continuous service subject to the maximum of fifteen percent which will be added to the marks secured by them for deciding the merit position.

Competency Based Skill Test (CBST)

- All the shortlisted candidates would be called in batches for competency based skill tests on 11 skills and related knowledge as per Objective structured Clinical Examination (OSCE) model.
- Candidates securing <70% in the CBST will not be eligible for selection.
- A final merit list will be drawn after the screening through CBST.

General Information and Instructions for Direct Applicants

- 1. The above positions are purely temporary and co-terminus with the scheme. Canvassing in any form will render the candidate disqualified for the position.
- 2. Details of vacancy, eligibility, ToR, age; application form etc. can be downloaded from the official website (www.koraput.nic.in).
- 3. Candidates are required to apply in prescribed format available in the website www.koraput.nic.in and to submit along with a set of self attested copies of all certificates in support of age, qualification, experience, residence etc. Candidates are also required to submit two recent passport size colour photograph, an ID proof (Voter ID/PAN/Driving License/Passport/Aadhar card) and recent valid Caste & Residence certificate issued by the competent authority. No certificate will be accepted at later stage of recruitment, if fails to produce with the application.
- 4. Candidates, who are already working in Health Department either on regular or on contractual basis, have to submit No Objection Certificate (NOC) from the employer (appointing authority) at the time of interview, without which they will not be eligible for appearing interview. NOC issued by any other authority other than appointing authority will not be accepted. NOC must be specific for the post, she/he applying and must be issued subsequent to issue of the advertisement.
- 5. For all the post candidates must have passed Odia up to M.E Standard.
- 6. Over aged, under qualification and short of requisite percentage of marks in the prescribed educational qualification shall be rejected.
- 7. Candidates will be selected on the basis of selection process as applicable. Only shortlisted candidates will be called for participation in the selection process
- 8. Incomplete application in any form will be rejected.
- 9. Age Relaxation is applicable only for the posts of Staff Nurse: Relaxation of 5 Year for Woman, SC, ST & SEBC category and 10 Year for Physically Disable, Ex-Sports Person, Ex-Serviceman category over & above the max eligible age of 32 yrs. A candidate can avail only one relaxation that is most beneficial to him/her.
