

- 1) **Guidelines for Selection of CRCCs for Engagement:-** In pursuance of Letter Nos. 2465/TT/03 Dtd. 26.08.03, Lr. No.10219(60)/Ped/07 dtd. 19.12.07, Letter No. 333/Ped/08 dtd. 10.01.08, Letter No. 3392/13 dtd.30.04.2013, Letter No. 10937/Estt./14 dtd. 11.12.2014, Letter No. 2969/Ped/19 Dated.11.04.2019 and Letter No. 2349/Ped/19 Dated.18.03.2019 of State Project Director, OPEPA, Letter No. 3420/Estt/14 dtd.29.04.2014 of Addl. Director (General) and Letter No. 7147/Ped/10 dtd. 08/09/10 of the Commissioner-cum-Secretary to Govt. S&ME Deptt. & SPD, OPEPA application forms are invited from the eligible Elementary Cadre Teachers/ ZP Cadre teachers of Koraput District for selection of CRCCs in Samagra Siksha, Koraput through Visioning Test on deployment basis.
- 2) **Vacancy Position:** There are 32 nos., of CRCC posts are lying vacant in different Blocks of the district which are to be filled up through visioning test. However, the vacancy position is subjected to vary keeping in view of vacancy from time to time and the authority reserves the rights to take any decision for filing up of vacancy as per the field requirement. The deployment of CRCCs will be made on the basis of Merit of Visioning Test. The decision of the Selection Committee is final.
- 3) **Eligibility Criteria for Deployment of CRCCs:**
 - i. Elementary Cadre teachers belonging to Level V/IV/Zilla Parishad Cadre Teachers for CRCCs. (as per the Letter No. 7147/Ped/10 dtd. 08/09/10 of the Commissioner-cum-Secretary to Govt. S&ME Deptt. & SPD, OPEPA)
 - ii. The teachers having departmental proceedings/charges of misappropriation of fund/criminal case pending shall not be allowed.
 - iii. Teachers who have been disengaged from the post of CRCC due to different reasons i.e. completion of 05 years of tenure, resignation misconduct, administrative exigencies etc. shall not apply.

4) **Documents to be Submitted:**

The interested teachers having requisite eligibility criteria have to submit the following documents:

- i. The detailed information in prescribed application-cum-bio-data format and undertaking through Block Education Officers of the district.
- ii. Self attested copy of all Educational & Professional Qualifications.
- iii. Two recent passport size colour photographs. (self attested)

The interested candidates shall submit their application to the concerned Block Education Officers by 31.07.2019 and the BEOs will submit the compilation of form to District Project Coordinator, Samagra Siksha, Koraput. Incomplete application and application received after the due date will be rejected.
