OFFICE ORDER


This engagement is purely on temporary basis and terminable at any time without assigning any reason there of.

This engagement is also subject to the following terms and conditions.

- I. Continuous unauthorized absence from duty without application for a period of 10 days or more shall automatically deemed to be termination of his / her services from office.
- II. He / She is not entitled to claim for inter medical college / District Transfer.
- III. He / She should report for duty within 10 days from the date of issue of this order failing which the engagement stands cancelled automatically.

1. Medical fitness certificate (Article-49) from a medical officer not below the rank of Assistant Surgeon.
2. Declaration to the effect that non-contract of plural marriage.
3. Conduct and character certificates issued by two Gazetted Officers.
4. Any other document for which undertaking is given for at the time of document verification.

An affidavit to the effect that the certificates/ documents and information submitted is correct and if found false/ fabricated / incorrect in future, then his/her appointment will be cancelled and action will be taken as per law & he/she will also not claim any financial benefits other than the monthly consolidated remuneration as per the post.
