

1. Applicant must be a citizen of India.
2. The Engagement will be purely temporary for a period of three months only (3 months) or till the COVID care Home (CCH) are functional whichever is earlier, keeping in view the emergency situation arising due to Covid-19.
3. The Engagement is terminable at any point of time without assigning any reason thereof. Further such engagement does not confer any right on the engagement for any further engagement/regularization of such engagement.
4. The remuneration shall be paid on daily wages basis as per the details mentioned in the above table.
5. In case of non availability of ANMs the unemployed staff Nurse/ Pharmacist can be engaged as mentioned above.
6. Place of engagement will be decided by the authority as per the requirement and the number of days to be work also to be decided by the authority as per workload.

10. Candidate selected to work for the said post will submit one undertaking regarding their duty as well as willing to serve in CCH Following Covid-19 guidelines.
11. Local District candidate will be given first preference due to present COVID19 pandemic situation in all over the State.
12. Residence certificate must be submitted along with Application form.
13. The merit list will be prepared basing on the marks secured in the qualifying exam. (GNM, ANM. Diploma in Pharmacy exam)
14. Knowledge in Odia: The candidate must-
  - a) be able to read, write and speak Odia;
  - b) have passed middle school examination with Odia as language subject; or
  - c) have passed Matriculation or equivalent examination with Odia as medium of examination in non-language subject; or
  - d) have passed in Odia as language subject in the final examination of class VII from a school or educational institution recognized by the Government of Odisha or the Central Government; or
  - e) have passed a test in Odia in Middle English School standard conducted by the School and Mass Education Department.

In case the marks obtained are in the form of CGPA, OGPA, DGPA, GPA, CPI etc., a certificate for conversion as applicable to percentage of marks shall be submitted at the time of submission of application form. Certificate towards AICTE recognition of institutions shall also be submitted at the time of submission of application form, wherever applicable, without which the application shall not be considered & shall be rejected.
16. Under qualification and short of any documents in the prescribed educational qualification shall be rejected.




