





Candidates are required to submit filled in application in prescribed format available in the official website : www.koraput.nic.in and attach a set of self attested photocopies of the certificates/documents in support of age, qualification and experience, Residence, Caste, two recent passport size colour photographs and self photo ID proof (Voter ID card /PAN card / Driving License /Aadhar Card /Passport).
