The CDPOs concerned are directed to allocate sectors to the Lady Supervisors consequent upon their joining in the project.

The candidates are directed to join in their respective place of posting mentioned above within 15 days from the date of issuance of this order failing which the order of appointment shall automatically stand cancelled.

**THE APPOINTMENT IS SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS :**

1. The appointment is purely temporary and can be terminated at any time without assigning any reason thereof.
2. They will continue on contractual basis for a period of six years and the appointing authority reserves the right to terminate the services of the employee if during the contractual period, the work and conduct of the employee is found to be unsatisfactory and the reason to believe that the employee is not suitable for the post. The period of six years shall be counted from the date of her joining in the contractual post.
3. They shall not be entitled to draw DA, HRA, RCM and Other Allowances during the period of contractual appointment.
4. On the date of satisfactory completion of six years of contractual service under sub-rule-10, they shall be deemed to have been regularly appointed as Supervisor. A formal order of regular appointment shall be issued by the appointing authority, then Pay and other benefits on regular appointment they are entitled to draw.
5. Any document proved to be contrary or forged on verification at any time, the services of the employee concerned will be terminated without assigning any reason thereof and prosecution will be initiated against her for submission of forged documents.
6. They shall be under the Contributory pension Scheme as per Finance Department Notification No. 44451/F, Dated 17.09.2005.
7. No TA will be allowed for joining in the post.

They should furnish the following documents /certificates in original at the time of joining in the post before the concerned Head of Office.

- 1.. All Original H.S.C. or equivalent Certificate in support of Educational Qualification. and for verification of the Date of Birth.
2. Original Caste Certificate issued by the competent authority.
3. A Medical certificate of fitness as required under Rule-49 read with Rule-50 of Odisha Service Code issued by a Medical Officer not below the rank of Assistant Surgeon.
4. Two character certificates from two Gazetted Officers
5. An oath of allegiance to the Constitution of India.
6. Affidavit to the effect that the candidate has not more than one spouse living.
7. Original Residence certificate issued by the competent Revenue Authority.
9. An undertaking in shape of an Affidavit to the effect that, no criminal case is pending against her. And the genuineness of their certificate.
10. Property statement in sealed cover as required under Odisha Government Servants Conduct Rules.
11. They shall execute an agreement with authority concerned for their contractual service as Lady Supervisor and to be governed under the provisions of Odisha Group-B posts (Contractual appointment Rules 2013) and amended from time to time.
