This engagement is also subject to the following terms and conditions.

4. Conduct and Character Certificates issued by two Gazetted Officers.
5. Any other document for which undertaking is given for at the time of document verification.
6. An affidavit to the effect that the certificates/ documents and information submitted is correct and if any document found false/ fabricated/ incorrect in future, then his/her appointment will be cancelled and action will be taken as per law
7. He/ she will also not claim any financial benefits other than the monthly consolidated remuneration as per the post.
8. Identity proof (Voter Identity Card/ DL/ Bank Pass Book/PAN Card).


