### **GUIDELINES FOR ENGAGEMENT OF PGTs/TGTs**

The candidates are advised to go through the eligibility criteria for different posts and they may go for online application after being satisfied that he/she is eligible for the posts as per stipulated eligibility criteria.

#### **ELIGIBILITY CRITERIA:**

In order to be eligible for appointment, a candidate must satisfy the following conditions:

- (a) Must be a Citizen of India
- (b) Must be of sound mind
- (c) Must not be having more than one spouse living.

#### **POST GRADUATE TEACHER (PGT):**

- Two years Integrated post Graduate Course of Regional College of Education of NCERT in the concerned subject with at least 50% marks in aggregate (45% for SC/ST/PH/ SEBC candidates) in the following subjects;
- OR**
- Master Degree in the concerned subject from a recognized University with at least 50% marks in aggregate (45% for SC/ST/ SEBC/PH candidates) in the following subjects:

#### **PGT (Chemistry) – Chemistry/ Bio. Chemistry**

##### **AND**

- Bachelor Degree in Education (a course prescribed by NCTE) from an Institution recognized by NCTE and affiliated to a recognized University.
- Proficiency in teaching both in Odia and English medium.
- Desirable: Knowledge of computer applications.
- **Note:** Candidates having Special B.Ed or D.Ed are not eligible for the post of PGTs.

#### **FOR ALL TRAINED GRADUATE TEACHER (TGT)S :**

- Four years integrated Degree course of Regional College of Education of NCERT in the concerned subject with at least 50% marks in aggregate(45% for SC/ST/PH/SEBC candidates)
- OR**
- Bachelor's Degree in Arts & Science in the concerned subjects with 50% in aggregate (45% for SC/ST/PH/SEBC candidates) along with a degree in Bachelor in Education (a course prescribed by the NCTE) from an Institution recognized by the NCTE and affiliated to a recognized University.

#### **TGT (Mathematics):**

- Bachelor Degree in Science with at least 200 marks in Math as a Subject with any two of the following subjects: Physics, Chemistry, Computer Science, Computer Application, Statistics.
- OR**
- B.Tech/B.E Degree with 200 marks in Math and any two of the following subjects: Physics, Chemistry, Computer Science, Computer Application, Statistics.

#### **TGT (Hindi):**

- Bachelor degree in Arts with Hindi as Honours subject.
- AND**
- Hindi Teacher Training certificate course (BH. Ed.) conducted by the Hindi Teachers' Training Institute, Cuttack, Bhubaneswar and Sambalpur, Hindi Sikhyan Parangata from Kendriya Hindi Sansthan, Agra and B.Ed. in Hindi. (A course prescribed by NCTE from Dakhin Bharat Hindi Prachar Sabha, Madras an institution recognized by NCTE & affiliation to a recognized university) will be considered as training qualification.

**OR**

- BA with Honours in any subject with Hindi as a subject for all three years.

**AND**

- Hindi Teacher Training certificate course (BH. Ed.) conducted by the Hindi Teachers' Training Institute, Cuttack, Bhubaneswar and Sambalpur, Hindi Sikhyan Parangata from Kendriya Hindi Sansthan, Agra and B.Ed. in Hindi. (A course prescribed by NCTE from Dakhin Bharat Hindi Prachar Sabha, Madras an institution recognized by NCTE & affiliation to a recognized university) will be considered as training qualification.

**OR**

- BA with Honours in any subject with Rastra Bhasa Ratna from Rastra Bhasa Prachara Samiti, Wardha.

**AND**

- Hindi Teacher Training certificate course (BH. Ed.) conducted by the Hindi Teachers' Training Institute, Cuttack, Bhubaneswar and Sambalpur, Hindi Sikhyan Parangata from Kendriya Hindi Sansthan, Agra and B.Ed. in Hindi. (A course prescribed by NCTE from Dakhin Bharat Hindi Prachar Sabha, Madras an institution recognized by NCTE & affiliation to a recognized university) will be considered as training qualification.

**OR**

- BA with Honours in any subject with Sastri from Odisha Rastra Bhasa Parisada, Puri.

**AND**

- Hindi Teacher Training certificate course (BH. Ed.) conducted by the Hindi Teachers' Training Institute, Cuttack, Bhubaneswar and Sambalpur, Hindi Sikhyan Parangata from Kendriya Hindi Sansthan, Agra and B.Ed. in Hindi. (A course prescribed by NCTE from Dakhin Bharat Hindi Prachar Sabha, Madras an institution recognized by NCTE & affiliation to a recognized university) will be considered as training qualification.

**OR**

- BA with Honours in any subject with Snataka (Acquired by June, 2005, the date up to which temporary recognition has been granted) from Hindi Sikhya Samiti Odisha, Cuttack.

**AND**

- Hindi Teacher Training certificate course (BH. Ed.) conducted by the Hindi Teachers' Training Institute, Cuttack, Bhubaneswar and Sambalpur, Hindi Sikhyan Parangata from Kendriya Hindi Sansthan, Agra and B.Ed. in Hindi. (A course prescribed by NCTE from Dakhin Bharat Hindi Prachar Sabha, Madras an institution recognized by NCTE & affiliation to a recognized university) will be considered as training qualification.

**OR**

- BA with Honours in any subject with equivalent degree in Hindi from recognized institution / University.

**AND**

- Hindi Teacher Training certificate course (BH. Ed.) conducted by the Hindi Teachers' Training Institute, Cuttack, Bhubaneswar and Sambalpur, Hindi Sikhyan Parangata from Kendriya Hindi Sansthan, Agra and B.Ed. in Hindi. (A course prescribed by NCTE from Dakhin Bharat Hindi Prachar Sabha, Madras an institution recognized by NCTE & affiliation to a recognized university) will be considered as training qualification.
- Proficiency in teaching in Odia and English Medium
- Desirable: Knowledge of Computer Applications.

**TGT (Sanskrit):**

- Bachelor Degree in Arts with Sanskrit as Honors Subject
- OR**
- Shastri (Sanskrit) with 50% in aggregate (45% for SC/ST/PH/SEBC candidates) a course prescribed by NCTE from recognized University.
- AND**
- Sikshya Shastri (Sanskrit), a course prescribed by NCTE from a recognized university/institution recognized by NCTE and affiliated to a recognized university will be considered as training qualification. (The B.Ed. qualification which is applicable for other TGTs is not applicable for TGT (Sanskrit))
- Proficiency in teaching in Odia and English medium
- Desirable: Knowledge of Computer Applications.

**SPECIAL PROVISION:**

- **Relaxation of B.Ed qualification :** In the absence of suitable candidates with B.Ed degrees in Hard / Very Hard station candidates with following qualifications may be considered in different categories without B.Ed qualifications-
  - a) Post graduate with 60% marks in science subjects and 55% in humanities subjects may be considered for the posts of PGTs, if suitable candidates with B.Ed are not available.
  - b) similarity in the case of TGT, B.Sc. with 10% marks and BA with 55% marks may be considered for appointment on part time contractual basis if suitable candidates with B.Ed are not available
- **Relaxation in CTET** – In the absence of CTET qualified candidates, candidates without CTET qualification may be considered if otherwise eligible.
