A set of tender document can be purchased from Office of the Zilla Parishad, Koraput, Main Road, Koraput, In front of Koraput Municipality on any working day from 03.12.2022 to 12.12.2022 between 10.00 AM to 05.30 PM at a non-refundable tender fee of Rs. 500/- (Rupees Five Hundred only) payable through demand draft of any nationalized bank drawn in favor of "CDO-cum-EO, ZP," payable at Koraput.
2. Tender Document can also be downloaded from 'Tenders' link of the District Headquarters website www.koraput.nic.in. and may be submitted along with above prescribed tender form fee by stipulated date & time. In case, tender documents are downloaded from website cost of tender documents i.e. Rs. 500/- shall be deposited.
3. Bidders are required to submit the technical and financial bids separately. The bids in sealed Cover-I containing "Technical Bid" and sealed Cover-II containing "Financial Bid" should be placed in third sealed cover super-scribed "Reservation/ Auction of stall for participation in the Pallishree Mela during PARAB-2022" must reach the undersigned on or before 12.12.2022 till 05:30 PM by hand/Speed Post/ Regd. Post/ Courier only.

Technical Criteria for Submission of Tender

1. Nonrefundable Tender Paper cost for Rs. 500/- (Either Money receipt duly received from ORMAS, Koraput or DD for 500/- in any nationalized bank in favour of CDO-cum-EO, ZP, Koraput who have downloaded the tender documents from the district website)
2. 20 number of Stalls will be reserved for the Bidders of Koraput District. Rest 60 Stalls will be open for all bidders, (including the Bidders of Koraput District)
3. Bidders participating for reserved shops from Koraput district will have to submit any one of the following valid documents, i.e. Artisan Card/ Company registration certificate/ Voter's Identity Card/Driving License/ Utility bill for the Private Firms.
4. Intending SHGs shall produce their valid Mission Shakti ID Number.
5. Bidders, who are interested for Food Stall, must have their valid FSSAI certificate / Food License.
6. One bidder can apply for one stall only. In case of multiple stall (limited to 3 nos.), the bidders must have valid undertaking/ affidavit that, the bidder shall not sublet the stall.
7. Duplicity of bidders may lead to rejection
8. Those bidders who are applying for multiple stalls, they shall use the stall in terms of single banner.
9. The price quoted below the offset price i.e. Rs. 17,000/- leads to rejection.
10. Intended bidders are requested to submit the quoted price in shape of DD in any nationalized bank in favour of CDO-cum-EO, ZP, Koraput.
11. The DD of unsuccessful/ rejected bidder shall be returned to them immediately.
12. The authority shall not be responsible for any postal delay.
13. The CDO-cum-EO, Zilla Parishad, Koraput reserves the right to accept or reject any or all the tenders without assigning any reason

Financial Criteria for Submission of Tender
