

Interested Bidders may purchase the tender paper from Municipal Office, Jeypore paying the paper cost and file the tender as per the terms and conditions detailed below.

- 1) Due date for submission of tender is 16/01/2023 through speed post/ registered post / in person addressed to the Executive Officer, Jeypore Municipality.
- 2) The tender should reach to the Executive Officer, Jeypore Municipality by 16/01/2023 and tender received after scheduled date shall not be entertained.
- 3) Rs. 30,000/- (Rupees thirty thousand only) to be submitted along with tender paper in the form of DD drawn in favour of Executive Officer, Jeypore Municipality. The EMD shall bear no interest. The EMD of unsuccessful bidders will be returned within one month from finalization of the tender and successful bidder will get back their EMD after completion of audit. In the event of Non-submission of EMD the tender will be rejected out-rightly.
- 4) Interested bidder may purchase the tender paper from Municipal Office on payment of Rs. 3000/- (Rupees three thousand only) in shape of DD drawn in favour of Executive Officer, Jeypore Municipality.



- 11) ~~The bid should be submitted through registered / speed post~~ addressed to the Executive Officer, Jeypore Municipality, At/PO Jeypore Dist. Koraput
- 12) The bidder should quote the price in tender paper inclusive of all taxes and duties.
- 13) It is the responsibility of the bidder to assess the items properly before quoting. No further claims will be entertained after opening of the bids.
- 14) The sale of the materials shall be on "As is where is basis"
- 15) Bidders cannot withdraw their offer after opening of the bids
- 16) The full payment of the offer price must be deposited by the successful bidder within 7 days from the date of issue of the Sale Order.
- 17) The successful bidder will have to lift the entire material and clean the site at its own cost within 15 days from the date of issue of the sale order
- 18) The quantity mentioned against each scrap items are approximate and the sale will be effected at actual at the time of taking delivery.
- 19) The authority reserves the right to add / delete / modify the list of items if found necessary.
- 20) All labour, tools and equipment for loading the items from site to the buyer's vehicle with all leads, lifts, etc. shall be at the cost of the buyer.
- 21) All payments are to be made in the form of DD / Banker's cheque drawn on any scheduled bank at Jeypore and made payable to the Executive Officer, Jeypore Municipality.
- 22) The undersigned reserves the right to accept or reject any offer or cancel the tender altogether, without assigning any reason thereof.
- 23) The disputes, legal matters, court matters if any shall be subject to Jeypore Municipality jurisdiction only.
- 24) In all matters, the decision of the Executive Officer, Jeypore Municipality will be final and binding.
- 25) Removal and transportation of materials shall be done only during working hours of Jeypore Municipality. No materials will be allowed to go out after 5.00 PM on week days. Similarly, no materials shall be allowed to go out on holidays.
- 26) The bids should be valid for 180 days from the date of opening of the bids.
- 27) The tenders shall be written legibly and free from erasing and overwriting, Corrections if any should be duly attested by the authorized signatory.
