Sealed tenders are invited from the reputed bidders to supply 24 nos. of Battery Operated Motorized Scooty for the PwDs with mutual consent of both parties.

1. This office has tentative requirement of 24 nos. of Battery Operated Motorized Scooty for the PwDs of Koraput District.
2. The bidder may **purchase the application form of tender** containing **Technical Bid & financial bid** information and term & conditions from the Office of the **District Social Security Officer, Koraput** at Saheed Laxman Nayak Bhawan, in front of Aurobinda School, Koraput on Cash payment of **Rs.2000/- (Rupees Two Thousand)** only from **dated: 17.01.2023 to 31.01.2023, during 11:00AM to 04:00PM in all working days**. The cost of tender fee is non refundable. The **original money receipt in support of purchase of Tender Paper should be enclosed** during submission of the bid.
3. The estimated cost for the tender is **Rs.17,61,000/- Rupees (Seventeen Lakhs & Sixty one Thousand) only**. (Rs.73,400 x 24 nos. including GST & Transportation Charges for delivery of the product)
4. The interested bidder may submit the tender document complete in all respect alongwith security deposit of **Rs.50,000/-(Fifty Thousand)** only in shape of **Demand Draft of any Nationalised Bank drawn in favour of District Social Security Officer, Koraput** and other requisite documents by **31.01.2023 upto 05.00PM** by Registered/Speed Post to the office of the **District Social Security Officer, Koraput at Saheed Laxman Nayak Bhawan, in front of Aurobinda School, Koraput**

General Instructions



Post** only. The authority shall not responsible for any postal delay.
2. All entries in the Tender Form should be legible and filled clearly, no overwriting or cutting is permitted in the financial bid as well as technical bid in such cases the tender shall be summarily rejected.

3. The technical bid & financial bid shall be opened in the scheduled date & time in the office Conference Hall of Collector, Koraput in presence of committee members & all the bidders/representatives. The financial bid of only those tenderers will be opened whose technical bid is found in order.

- STATUTORY REGISTRATIONS** : The tenderer must have valid PAN No. and GST No. Photocopy of PAN Card of the Firm/Dealer/Proprietor and Tax return for last 3 years is to be submitted with the technical bid. Original Tender Document duly signed with seal of the firm on each page in token of acceptance of the terms and conditions of tender.
- The undertaking (Annexure-“C”) duly signed by the tenderer.

1. PROCEDURE FOR SUBMITTING TENDERS

The Tenders are to be submitted as per two bid system i.e. Technical bid and Financial Bid.

Technical bid should contain the papers to fulfill all the eligibility criteria, proofs of experience, proofs of turnover, proof of address, undertaking as per instructions etc.

1. Financial bid should contain the rates quoted for the services to be provided as per the instructions given in this tender document.

Both the bids should be submitted in two separate sealed envelopes super scribed as “**Technical Bid for supply of battery operated motorized scooty for PwDs**” to the **District Social Security Officer, Koraput**” and “**Financial Bid for Supply of battery operated motorized scooty for PwDs** ” respectively. An amount of Rs. 50,000/- (Rupees Fifty Thousand only) as security deposit in shape of **Demand Draft** only of any nationalized bank should be placed at the top of the technical bid. Both the envelopes containing **Technical bid and Financial bid** should be put in a third sealed envelope and should be super scribed “**Tender for supply of battery operated motorized scooty for PwDs**”. Sealed tenders should be addressed to the District Social Security Officer, Koraput, In front of Aurobinda School, Koraput-764020.

2. PRICES:

1. Price should be quoted for all the items listed in Annexure "B" without any overwriting/erasing/cutting. Use of white fluid/ correction fluid/ correction tape is strictly prohibited.
2. Financial Bids should be inclusive of all taxes, transportation charges and packing charges.
3. Conditional bids shall be rejected.
4. The rates for the quoted items should not be higher than those quoted in any other organization/institution or the M.R.P.
5. Successful tenderer shall not be entitled to any hike in prices for any reason other than statutory taxes after getting the tender.
6. **The unit cost per one Battery Operated Motorized Scooty must not be exceed an amount of Rs.73,400/-Rupees (Seventy Three Thousand Four Hundred) only.**
3. **RIGHT OF REJECTION OF TENDER:** The Collector & District Magistrate, Koraput reserves the rights to reject all/ any bid without assigning any reason.
4. **EVALUATION OF BIDS:** On the basis of assessment of general conditions and receipt of Security Deposit, Technical Bids of only qualified bidders shall be considered for evaluation by the Technical Evaluation Committee constituted by the Competent Authority. Thereafter, on the basis of the evaluation of Technical Bids, the financial bids of only those technically accepted offers, shall be opened for evaluation. The final award of tender shall be made to the lowest qualified bidder on the basis of total cost of procurement (inclusive of all taxes) worked out in the Financial bids.
