### TERMS AND CONDITIONS

1. The amount put to tender as per column-3 above are excluding GST.
2. The Tender Paper can be obtained from the Block Office, Nandapur on payment of cost of the tender paper( non-refundable) in shape of cash. The tender paper will be sold from **06.02.2023 to 09.02.2023** on working days only from 10.00 AM to 1.00 PM in the office of the Panchayat Samiti, Nandapur. The sealed tender papers will be received on working days till **3.00 PM of 13.02.2023**. The sealed tender papers should be submitted through **Registered Post** only addressed to the Block Development Officer, Nandapur, District: Koraput(Odisha) and by no other means. On the top of the envelop it should be clearly written **"Tender Paper"** and **"Name of the project"** for which project the bidder want to participate in tender. The undersigned will not be held responsible for any delay in postal services. The tender papers received through postal service will be opened at **11.00 AM on 15.02.2023** in presence of the Tender Committee and Contractors or their authorized representatives.
3. Bidders should furnish EMD in shape of NSC/KVP/Post Office Term deposit/Term Deposit Receipt of any Nationalised Bank duly pledged in favour of **"Block Development Officer, Nandapur** along with tender documents. The tender papers without required amount of EMD will not be considered & transfer or adjustment of EMD is also inadmissible.
4. The successful bidder, whose tender will be accepted is required to deposit one percent of the tender value against the work in shape of NSC/KVP/Post Office Term deposit/Term Deposit Receipt of any Nationalised Bank duly pledged in favour of **"Block Development Officer, Nandapur** at the time of acceptance of tender.
5. The following documents should be furnished along with the tender papers failing which the tender will be liable for rejection.
  - \*EMD pledged in favour of Block Development Officer, Nandapur.
  - \*Original money receipt granted by BDO, Nandapur towards cost of tender paper.
  - \* Self attested copy of Contractor Registration certificate.
  - \* Self attested copy of PAN Card.
  - \* Self attested copy of GST Registration Certificate.
  - \* Self attested copy of GST Clearance certificate.
  - \* Self attested copy of Caste certificate for SC/ST contractor desirous of availing preference.
  - \* Original Affidavit of no relation certificate.
  - \* Original Affidavit about authentication of documents submitted.
  - \* Past performance certificate (if any).

6. The Engineering Contractor desirous of availing exemption of EMD should submit an Original affidavit to the effect that he has not availed exemption of EMD facility more than three times in the current financial year.

7. A bidder can submit only one tender paper for one project. Submission of more than one tender paper by a bidder for the same work is liable for rejection.

8. The bidder shall furnish an affidavit at the time of submission of bid about the authentication of the tender documents including the above required documents failing which the bid shall be considered as non-responsive and thus will be liable for rejection.

9. For tender quoting less rate from the amount put to tender, if his/her tender is considered to be accepted then the differential cost will be deposited by the contractor before agreement in shape of NSC/KVP/Bank TDR in favour of **Block Development Officer, Nandapur.**

10. The tenderer should quote the tender below 15%(Fifteen percent) less rate from the amount put to tender and not in excess to the amount put to tender or else the tender paper will be rejected. The EMD amount will be forfeited if the tenderer backs out from the offer of acceptance of tender by the competent authority and the EMD amount will be forefieted. The tenderer has to show all required documents as mentioned above in original at the time of opening of the tender for verification.

The authority deserves all and every rights to reject or cancel any or all tenders without assigning any reasons thereof.
