

**DETAILS OF TERMS AND CONDITIONS FOR SUBMISSION OF TENDER PAPER
BY THE TENDERER FOR TRANSPORTION OF FOOD STUFF UNDER PM POSHAN,
MID-DAY-MEAL FEEDING PROGRAMME FOR THE YEAR 2023-24.**

1. Sealed tenders in the prescribed form are invited from the intending Individuals / Company / Firms / Corporations for undertaking transportation of food-stuff of Mid Day Meal Feeding Programme from OSCSC Godown of Koraput District to School points of Koraput District during 2023-24. The intending tenderers may apply for **one or more Blocks** as mentioned at **Annexure-1**. The tender papers complete in all respect should be sent in the address of **DISTRICT PROJECT MANAGEMENT UNIT, PM POSHAN (MDM) Scheme, O/o District Education Officer, Koraput, PIN- 764020 by Registered Post/Speed Post only so as to reach before 4.00 pm of 10.04.2023**. The Tender papers received beyond the scheduled date and time will be liable for rejection. No tender paper will be received by hand, telegraphic Tender and Conditional Tender will not be accepted. The tender paper will be opened on 11.04.2023 at 11.00 am by the tender committee under the chairmanship of collector, Koraput in the conference hall of district Education Office, Koraput.
2. The tender should not be a Rice Miller / OSCSC Ltd H&T contractor Level-1 & Level-2. **An affidavit** to this effect sworn before the Executive Magistrate or the Notary along with Non-involvement and non-pendency of any criminal offences and also about No-Government-Dues pending against him must be enclosed with the tender paper.
3. **An Affidavit** regarding non conviction under Prevention of Food Adulteration Act & Prevention of Black Marketing Act.
4. List of Trucks owned or leased by the tenderer with up-to-date documents including Registration Certificate of vehicles (Xerox copy duly self attested) has to be furnished along with tender. The tenderer should have minimum two trucks (HMV), three nos. of MGV and five nos. of light vehicles (Goods Carriers) standing in his own name. All the vehicles should be less than 15 years old.
5. The tender paper must be accompanied with a Demand draft of Rs 15,000/- Rupees (Fifteen Thousand) only towards Bid Document Cost along with all other relevant documents as specified in the tender form at Annexure-II. In case of failure to comply the instruction specified thereon or non submission of any of the documents specified, the tender shall summarily be rejected.
6. The successful tenderer(s) shall be required to lift foodstuff under PM Poshan (MDM) Scheme from OSCSC Godown as per release order issued by CSO-cum-DM, OSCSC, Jeypore and transport the same to School points as per the diversion order issued from the DPMU (MDM) Koraput/BPMU (MDM) within the specified period. The stock should be handed over to the Head Masters on proper acknowledgment on 03 (three) challans out of which one shall be retained by the transporter and other two will be left with the Headmaster concerned. It is the responsibility of the tenderer / transporting agent to lift the rice from the OSCSC Godown on proper weighment and deliver the same to the school point on proper weighment and in no case short supply or delivery shall be allowed. The Transporting Agent will deliver the stock to different School points under the administrative control of concerned authority. The Transporting Agent will be held solely responsible for making delivery of stock at the desired point and no request for relief / consideration shall be entertained in case of shortage or damage noticed (if any) during transit. The cost of shortage/pilferage/transit loss will be borne by the transporting agent. There shall not be any change in quantity of food grains. The quantity of the food materials being transported may be inspected by the Govt. Officials authorized by the Collector, Koraput during transit and also at delivery points. If any misappropriation/shortage is noticed during inspection or otherwise, penalty shall be imposed which would be equivalent to 3 times of market price of the cost of misappropriated/shortage food grains in addition to initiating criminal case under the relevant laws.

7. The tender should be filled in properly and legible without any over writing. The rates should be written both in words and figures in the tender. The rate quoted should be final and the tenderers shall not be allowed to change the same under any circumstances and it should be valid for the year 2023-24.
8. Earnest money of Rs.1,00,000/- (Rupees One Lakh) only per Block is to be deposited along with the tender paper in shape of NSC / TDR in favour of District Education Officer-cum-District Nodal Officer, PM Poshan (MDM) Scheme, Koraput payable at any nationalized Bank, Koraput. Any other form of payment shall not be accepted. The tenders without Earnest Money shall be liable for summarily rejection. Earnest money of unsuccessful tenderer shall be refundable after finalization of tenders. However in case of the successful tenderer, if he / she fails to enter into an agreement in the prescribed format within the prescribed time for transporting the commodities, the EMD shall be liable for forfeiture.
9. Last three years Income Tax Return & PAN Card from the competent authority must be furnished along with the tender paper.
10. The tenderer must submit valid attested copy of Solvency Certificate of Rs.30,00,000/- (Rupees Thirty lakhs) only issued by the competent Revenue Authority during 2022-23 & 2023-24 along with the tender paper.
11. Telegraphic or conditional tender shall not be accepted.
12. In case the successful tenderer refuses to execute work of Transporting Agent after acceptance of his tender by the committee the Earnest Money Deposited by him stands automatically forfeited.
13. An attested copy for common carrier license of valid agent license issued to the tenderer under the Carriage by Road Act 2007 and Carriage by Road Rules 2011 of State Transport Authority should be enclosed with the tender paper.
14. Payment shall be made against submission of bills with challans duly acknowledged by the recipient and other relevant documents within two months from completion of delivery of food-stuff, as per approved rates incorporated in the agreement within one month of receipt of bills subject to availability of funds. The Chairman, District Tender Committee concerned shall have the right to deduct and adjust any amount found recoverable towards loss/shortage/pilferage/transit loss and damage or both.
15. No advance payments of transportation bill shall be allowed.
16. Payment of bill is subject to availability of funds and no interest can be claimed on delayed payments.
17. The successful tenderer(s) shall have to enter into an agreement with the District Education Officer & District Nodal Officer, PM Poshan (MDM) Scheme, Koraput as per terms and conditions specified by the Government within 07 days of the intimation of acceptance of his / her tender.
18. The authority may terminate the contract for violation of terms and Agreement or for any other reason to be recorded in writing.
19. The work is to be carried out with due diligence and in accordance with the instruction to be issued from time to time by the Government.
20. If the Transporting agent fails to transport the food-stuff within the time limit, then the Authority will take immediate steps to transport the same by other means and the extra cost incurred will be recovered from the pending bill / EMD or both of the Transporting agent.
21. The tender committee will judge the feasible rate of transportation to award/accept the tender. The Tender shall not be awarded to the bidder quotes the lowest rate, if the rate is not feasible.
22. The bill should be submitted within two months from completion of delivery of stock along with all relevant documents and papers as per order of the competent authority.
23. The Chairman, District Tender Committee may terminate the contract for violation of terms of agreements at any point of time and shall be prosecuted under IPC/Essential Commodity Act.

24. The tenderer should have at least two Trucks (HMT), three MGV and five small vehicles (LMV) with valid R.C. Book, Valid Insurance, Road Permit, PUCC and Fitness Certificate to be attached with tender papers. The vehicles should not be more than 15 years old.
25. Payment shall be made subject to the availability of funds. The authority shall have the rights to deduct or adjust any amount from the bills towards any loss and damage or both. No advance payment shall be made nor will interest be claimed for delay in payment.
26. Tenderer may submit experience certificate if any, in the field of transportation of food materials in Government sponsored Programme shall be given priority.
27. The food grains rice should be transported directly to school point and the delivery shall be made at the school point and challans (to be printed by the Transporting Agents) duly acknowledged by the Headmasters shall be submitted within 7 days to the concerned Block Education Officers who will in turn submit the consolidated acknowledgement certificate to the District Education Officer cum District Nodal Officer, Koraput for further action.
28. Tender received without required documents shall not be considered and liable to be rejected at the initial stage itself.
29. The selected Tenderer(s) should abide the instruction and guidelines to be issued by the authorities from time to time.
30. The Bidder shall carefully go through all the terms and conditions of the tender document and submit the tender papers in correct and complete form. The tender paper should be filled in properly and legibly without any correction / overwriting. No opportunity shall be given to the tenderer to rectify or amend any defect detected at the time of scrutiny.
31. For smooth distribution of food stuff under PM Poshan (MDM) Scheme, the District Tender Committee reserves every right to appoint more than one transporting Agent for the District on negotiation.
32. The Collector & District Magistrate, Koraput reserves every right to reject any or all tenders received without assigning any reason thereof.
