

**MINUTES OF THE MEETING FOR OPENING OF FINANCIAL BIDS FOR HIRING OF DLSA UNDER REWARD PROGRAM FOR KORAPUT DISTRICT HELD ON DATED 28.04.2023, 11.30 AM AT THE OFFICE CONFERENCE HALL OF PROJECT DIRECTOR, WATERSHEDS, KORAPUT.**

The meeting for opening of financial bids for hiring of District Level Support Agency (DLSA) under REWARD Program for Koraput district chaired by the CDO-cum-EO, Zilla Parishad, Koraput was held on dated 28.04.2023, 11.30 AM at the office conference hall of Project Director, Watersheds, Koraput. The participants attended the meeting is annexed as **Annexure-I**. The agenda of the meeting was to open the financial bids of the technical qualified agencies and shortlisted them as per their combined technical and financial score.

The meeting was started with extending a very warm welcome by the chair to all the participants participated in the meeting and the chair instructed to proceed with opening procedures of financial bids of technical qualified agencies. The following agencies have been technical qualified during the technical evaluation held on dated 18.04.2023, 11.30 AM at the office conference hall of P.D, Watersheds, Koraput.

- 1. Life Academy of Vocation Studies, Bhubaneswar.
- 2. Shakti Organisation, Rayagada.
- 3. PARIVARTTAN, Malkangiri.

Before all else, the committee requested all the qualified agencies to produce the proof of depositing of 18% GST amount on tender processing fees i.e ₹ 1,800/- (Rupees one thousand) Only each. All the technical qualified agencies produced the proof of depositing the above GST amount and the committee instructed to the Project Director, Watersheds, Koraput to refund the GST amount to the agencies who deposited the same. In regard to non-responsive agencies i.e Gopabandhu Development Society, Malkangiri and Society for the Welfare of Weaker Section, Gajapati, who failed to deposit the GST amount despite being requested to them vide letter No. 918 dated 20.04.2023 of P.D, Watersheds, Koraput, the committee unanimously decided that the said GST amount will be refunded to the above agencies with a request to deposit the same at their level on Reverse Charge Mechanism (RCM) under GST.

After opening of sealed envelopes contained the financial proposal of the qualified agencies, the name of the agency, the quality score and proposed price

read aloud one by one and recorded in the financial bid statement, annexed as **Annexure-2**.

Thereafter, the committee ranked and shortlisted the agencies according to their combined technical and financial scores evaluated as indicated in the data sheet using the weightage for technical and financial scores are 70% and 30% respectively. The details of which is annexed as **Annexure-3**. The Life Academy of Vocation Studies, Bhubaneswar achieved the highest combined technical and financial score. He will be invited for negotiation as per the condition stipulated in the Request for Proposal and after getting approval from the Director, Soil Conservation & Watershed Development, Odisha, Bhubaneswar. The date, time and venue of negotiation will be intimated to the agency through e-mail in due course.

The committee further decided that the financial proposal of the agencies who did not meet the minimum qualifying mark and non-responsive to the RfP and ToR i.e Society for the Welfare of Weaker Section, Gajapati and Gopabandhu Development Society, Malkangiri respectively will be returned unopened to them after completing the selection process. The minute of the meeting is published in the district website of Koraput district.

The meeting ended with votes of thanks to the chair.
