TERMS AND CONDITIONS

1. The tenderers will have to submit an earnest money for ₹ 43,000/- (Rupees forty three thousand) Only in shape of Demand Draft in the name of the Project Director, Watersheds, Koraput payable at Koraput in any Nationalize Bank along with application form on or before **08.08.2023** at **1.00 PM** through Regd./ Speed post/ Courier service. The Tender will be opened by the tender committee in presence of the tenderers or their representatives on dated 08.08.2023, 3.00 PM at the conference hall of Project Director, Watersheds, Koraput. The earnest money shall be treated as security deposit and the same will be adjusted against the cost of the sisal fibers. The earnest money of the other tenderers will be returned to them after finalization of the tender process. Tender without earnest money and received after the due date and time will not be considered.
2. The tenderers must quote their rate for sisal fibers on per Kg. basis, ex-go down and exclusive of taxes. The offset price of sisal fibers per Kg. is ₹ 100/- (Rupees one hundred) only. The tenderer will have to pay the actual cost for loading and transportation of sisal fibers.
3. The tenderers may inspect the sisal fibers in the godown located at Soil Conservation Training Institute, Koraput in any working days from 10.00 AM to 5.30 PM.
4. The tenderers should be registered with GST. The applicable GST will be deposited by the tenderer on Reverse Charge Mechanism (RCM) under GST, as the client is not registered under GST. A copy of the GST paid challan should be submitted to the Project Director, Watersheds, Koraput before lifting the sisal fibers. Tender papers without GST No. will not be considered.
5. Full payment as per quoted rate should be made before lifting of sisal fibers, otherwise the rate contract can be terminated.
6. The tenderer will have to lift all the sisal fibers within 7 days from the date of finalization of tender, failing which the rate contract will be terminated with forfeiting of earnest money.
7. Once the stock of sisal fibers is lifted from the godown, the same cannot be returned back on quality ground or any other ground of whatever nature and no complaints thereof will be entertained.
8. The Project Director, Watersheds, Koraput reserves the right to cancel or to accept the tender/s without assigning any reason thereof.
