Tender document sent other than the above mode shall not be entertained in any circumstances. The tender paper shall be available at DSW Section, Koraput during the office hours from dated **13.06.2018**. The prescribed tender schedule can also be downloaded from the District Web site <http://Koraput.nic.in> and can be filled alongwith a DD of Rs. 5000/- (non refundable) drawn in favour of DSWO, Koraput in SBI, Koraput and payable at Koraput towards the cost of tender paper along with EMD. Opening of Financial and technical bids on **02.07.2018** at 4.00 PM in the Office or chamber of **Collector, Koraput** in presence of the Tender Committee constituted for this purpose and the bidders or their authorized representative. The tenderer should submit the attested copy of valid GSTN clearance certificate, income tax clearance certificate and PAN Card alongwith the tender paper. The rate should be inclusive of all taxes and shall furnish the effective sale and source certificate and deliveries of the materials are to be made in the AWC point. The successful tenderer shall supply the materials within 90 days from the date of the receipt of the supply order in the AWC point. No transportation cost will be given to the selected supplier. The successful bidder shall supply the materials in the approved rate. This office is not responsible for any kind of delay in receipt of the tender documents. If the successful tenderer will not supply the materials in the approved rate, the EMD shall be forfeited and credited in to the account of the DSWO, Koraput.

DETAILED TENDER NOTICE AND TERMS AND CONDITIONS FOR SUPPLY OF STEEL ALMIRHAS TO AWC HAVING OWN BUILDING (UNDER NOP) IN THE KORPAUT DISTRICT.

1. Sealed Tenders in the prescribed form are invited, from the intending credible firms having valid/ updated VAT/ GSTN/ PAN holder for supply of Almiraha (under NOP) for supply to AWCs having own building in 15 Nos. of ICDS Projects of Koraput District.
2. The tender paper must reach the Collector (DSWO Section), Koraput by Registered post/ speed post/ courier for this purpose on or before dated 29.06.18 till office hours.
3. The detailed tender papers along with prescribed Tender Schedule (Annexure-I to III) can be obtained on payment of Rs. 5000/- (Rupees five Thousand) only (Non-refundable) from the Accounts section of DSWO, Koraput during the office hours from Dtd. 13.06.18 to Dtd. 29.06.18. The money receipt thereof is to be submitted alongwith in the tender forms. The prescribed tender schedule can also be downloaded from the District Web site <http://Koraput.nic.in> and can be filled alongwith a DD of Rs. 5000/- (Rupees Five thousand) drawn in favour of DSWO, Koraput in SBI, Koraput and payable at Koraput towards the cost of tender paper along with EMD.

SPECIFICATION/ TECHNICAL AND FINANCIAL BID & GENERAL TERMS AND CONDITION FOR SUPPLY OF ALMIRAH (UNDER NOP)

1. The specification and the quantity of Almirah to be supplied are as per Annexure-III.
2. The bidders should submit bids in two envelopes, one containing the financial bid indicating the unit cost and the other should be the technical bid only. Both the envelopes should be super scribed accordingly. Both the covers should be placed in a big sealed cover super scribing “**SUPPLY OF STEEL ALMIRAH (UNDER NOP) FOR AWC IN THE KORAPUT DISTRICT**”.

2 (a) **TECHNICAL BID**

The Technical bid should contain the following.

- I. Money receipt/DD of Rs. 5000/- in favour of DSWO, Koraput
- II. Past Performance.
- III. Self declared Technical competence & production capacity details.
- IV. Copy of the Annual Income & expenditure for last two year 2016-17 & 2017-18.
- V. A demand draft/ TDR of Rs. 3,50,000/- (Rupees Three lakhs Fifty thousand) only as EMD from State Bank of India payable at Koraput drawn/ pledged in favour of the **District Social Welfare Officer, Koraput**, refundable without interest.
- VI. Attested copies of VAT cleared earlier/ valid registration certificate under industry department in EM II and up-to-date tax payment clearance.
- VII. Attested copy of the PAN Card.
- VIII. Tender paper in Annexure I, II & III signed in each page.
- IX. Copy of TIN / GSTN Certificate
- X. The Agency should be from the approved list of Directorate of Export Promotion and Marketing having valid rate contract. Prices for the Goods should be paid as per the valid rate contract. The other salient terms and conditions of the purchase should be in line with those specified in the rate contract.

2 (b) **FINANCIAL BID**

- I. The financial bid should contain the Unit price for supply of Almirah (under NOP) for supply to different ICDS Projects of Koraput District in the prescribed format in Annexure – IV of the tender paper and the price quoted must be inclusive of all taxes, loading, unloading, transportation and delivery at 1777 AWC Point.
- II. The budget for procurement of Almirahs is Rs. 5000/-(Five Thousand)only per AWC. The ceiling amount of Rs. 5000/- includes transportation and tax as applicable.

The Financial bid should be filled in properly and legibly without any correction/ over writing. The rate and units should be written both in words and figures and it should be serialized. The rate quoted should be final and the tender shall not be allowed to change the same under any circumstances.

OTHER TERMS AND CONDITION

1. The supplier has to supply the Almirah as per specification at the AWC point in good condition and obtain the receipt from the AWW duly counter signed by the ICDS Supervisor concerned.
2. The agency finalized for supply of a sample to DSWO, Koraput before bulk production will only be taken up by the supplier only on approval of the sample by the Authority.
3. The agency finalized for supply of Almiraha should fully understand the expected quality & quantity of production along with specification of the Almirah.
4. The successful bidders shall be required to supply the required quantity of Almiraha at concerned AWC point within 90 Days of the indent placed with the supplier.
5. Batch wise quality checks will be conducted by drawing samples of the finalized product at the production point, as well as at delivery point at O/O the DSWO.
6. The intending supplier should deposit Rs. 3,50,000/- (Rupees three lakhs fifty thousand) only as EMD in shape of DD in favour of the DSWO, Koraput along with the tender in Technical bid which will be kept as security deposit. The amount will be refunded in case of unsuccessful bidders without interest.
7. Earnest Money deposited by the successful tenderer will stand converted to security deposit which will be refunded after successful completion of contract period and audit of accounts of the supplier. The whole or part of the Security Deposit will be forfeited for irregular performance or breach of any terms(s) and condition(s) of agreement during the period of Earnest Money.
8. In case of disputes about the quality, Collector or his authorized representative(s) will initiate an enquiry and take suitable action including debarment against the supplier.
9. The supplier will hand over delivery Challan in support of delivery of the Stock at O/o the DSWO along with his claim bill.
10. Any claim of the Govt. remaining unpaid by the supplier towards this supply shall be recoverable as a public demand under the Orissa Public Demand Recovery Act' 1962.
11. If any question or dispute shall at any time arise between the parties here to touching or arising out of or in respect of this supply, then the same shall be referred to the appropriate court or tribunal constituted by the Govt. of Odisha whose decision will be final, conclusive and binding on both the parties.
12. Tenders received after the stipulated date and time or without sample shall be liable for rejection.
13. The Authority reserves the right to reject any or all tenders received without assigning any reason thereof.
14. The bidder has to sign in each of the tender paper as a token of acknowledgement of acceptance of the Terms, conditions, Specification etc.
15. Funds will be placed with the DSWO for the purchase of Almirah
16. Almirah to be supplied to AWCs having own building
17. The agency shall be selected through a District Level Purchase Committee Chaired by the Collector/ ADM of the District

18. The agency should be from the approved list of Directorate of Export promotion and Marketing having valid rate contract. Prices for the goods should be paid as per the valid rate contract. The other salient terms and conditions of purchase should be in line with those specified in the rate contract.
19. DSWO is required to follow the guidelines for procurement of Goods of the Finance Department vide letter No. 4939 Dtd. 13.2.2012.
20. The sample of the almirahs to be supplied is to be placed before the purchase committee and supply is to be made as per the sample presented.
21. A list of AWCs is enclosed separately where the Almirahs is to be supplied to the Agency.
22. The Selected agency is required to deliver the Almirah at the AWC level. Contract is to be awarded on the same conditions.
23. The AWW will acknowledge the receipt of the Almirah. The agency will submit a copy of the receipt challan copy of all Almirahs with the DSWOs office for settlement of bills.
24. DSWOs should personally test check specification of 20% of the Almirahs on a random basis with the sample shown prior to the clearance of bills of the supplier/ agency.
