TENDER CALL NOTICE

The Block Development Officer, Koraput invites percentage sealed tenders in conformity with the Tender Call Notice (TCN) from the registered contractors of State PWD / M.I. / Irrigation / Rural works/CPWD/PHD for the following works under Koraput Block to be eventually drawn in PWD P-1/F-2 agreement as detailed below. The amount put to tender and bid security may be changed and confirmed at the time of selling of tender documents.

TERMS AND CONDITIONS:-

1. The details of work including the estimated cost, Tender value, EMD, Required class of contractor, completion time, cost of tender paper, place of selling of tender paper etc. are available in the website '<http://www.drdakoraput.org>.' or '<http://www.koraput.nic.in>'. The Bidders has to deposit required amount toward cost of the tender.
2. Tender documents for the individual work may be obtained from the office of the **Block Development Officer, Koraput** on payment of cost (non refundable) of the tender paper in shape of **Bank Draft/Bankers cheque** drawn on any nationalized bank in favour of **Block Development Officer, Koraput**.

3. The Tender papers will be sold from **26.06.2018 to 03.07.2018** (working days only) up to **3.00 PM** in the office of the **Panchayat Samiti, Koraput**. Sealed Tender papers will be received from **27.06.2018 to 04.07.2018 up to 3.00 PM** on working days only in the office of **Panchayat Samiti, Koraput** through **registered post/speed post** only. The tender papers received after the stipulated date and time will not be considered. No tender papers will be received by hand or by courier service. The tender papers shall be opened on **04.07.2018 at 4.00 PM (Wednesday)** onwards in the **office chamber of Block Dev. Officer, Koraput** in presence of the bidders or their authorised representatives having written authorization for the purpose.

4. The following documents should be furnished along with the tender papers failing which the tender is liable for rejection.

- a) EMD duly pledged in favour of Block Development Officer, Koraput.
- b) Attested copy of the contractor Registration certificate.
- c) Attested copy of PAN cards & GSTIN, GST Reg. Certificate.
- d) An affidavit in support of the authenticity of the documents including EMD should be attached with the tender paper.
- e) The Engineering contractor desirous of availing exemption of EMD should submit an affidavit to the effect that he has not availed exemption of EMD facility more than three times in the current financial year.
- f) SC/ST Contractor desirous of availing preference should submit an affidavit in support of caste certificate and attested copy of recent caste certificate (issued within last one year) otherwise their tender will be liable for rejection.
- g) Bidder should submit experience certificate having executed similar nature of works earlier.

5. Bids must be accompanied with EMD as specified above in shape of TDR deposit receipt of schedule Bank/Kissan Vikas Patra/National Saving Certificate/Post office time deposit duly pledged in favour of Block Development Officer, Koraput.


6. Additional performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand Draft / Term Deposit Receipt pledged in favour of the Block Development Officer, Koraput within seven days otherwise the bid shall be cancelled and the Security Deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder as per works Department office Memorandum No.14299, dtd.03.10.2017.

7. The detailed list of successful bidders against each work will be displayed in the notice board. The successful bidders will collect the letter of acceptance from the office of the undersigned within seven days from the date of declaration of list of successful bidders on the notice board in order to avoid postal delay for early execution of the work. No further claim will be entertained for non receipt of the acceptance letter.

8. The EMD amount is to be forfeited if the tenderer backs out from the offer of acceptance of tender by the competent authority.

9. The cover containing the tender paper should be super scribed at the top "Tender work for Panchayat Samiti, Koraput" only. The name of the work should not be mentioned.

10. The Tender papers will be received through Registered post/Speed post only. No tenders will be received by hand or by courier service. The undersigned will not be held responsible for any delay in postal service.
11. In case of shortfall of any required documents, the tender papers is liable for rejection.
12. Since the works are time bound programme, the tenderers have to complete the same within the specified time. Penalty will be imposed as per laid down guidelines in P.S.A.P. Rules 2002.
13. The tenderer has to show his original documents (Contractor license, PAN card, GSTIN, GST certificate, caste certificate in case of SC/ST/Engineering contractor license (for engineering contractor etc.) at the time of opening of the tender papers.
14. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.


