INSTRUCTION TO TENDERERS

1. INVITATION :

Sealed Tenders are invited from reputed and experienced FRP Boat builders only who have adequate and requisite experience and have manufactured FRP Passenger Boats of size not less than 8.20 Mtr. long fitted with Engine & supplied to State/ Central Govt. and Quasi Govt. organizations.

2. PURCHASE OF TENDER DOCUMENTS :

2.1 The Tender documents will be made available on sale from the Emergency, Section, Collectorate, Koraput from 05.07.2018 to 16/07/2018 up to 3.00 P.M. in working days only. The tenderers may download from the website www.koraput.nic.in & he has to submit the paper cost in shape of D.D drawn in favour of the 'Deputy Collector, Emergency, Collectorate, Koraput' payable at Koraput.

2.2 Request for Tender documents shall be accompanied with cost of tender paper in shape of Cash or D.D. The cost of the Tender documents will not be returned under any circumstances.

3. SUBMISSION AND OPENING OF TENDERS :

3.1 Tenders are to be submitted in original in a sealed cover with financial bid to be placed in a **separate sealed cover**.

3.2 The sealed cover should be super scribed "**Tender for supply of 20 Seater FRP Boats for ferry use**".

3.3 The Tender shall be addressed to the Collector, Koraput, Emergency Section.

3.4 The last date of submission of Tender is **16/07/2018 up to 3.00 P.M** by Regd. Post / Speed Post/ in person.

3.5 The Tenders will be opened at the office chamber of the **ADM, Koraput at 4.00 P.M. on 16/07/2018** in the presence of the Tenderer or his authorized representative as well as Tender Committee members.

4. EARNEST MONEY DEPOSIT :

- 4.1 Earnest Money Deposit indicated in shape of **NSC/TDR/ FDR** duly pledged in favour of the 'Deputy Collector, Emergency, Collectorate, Koraput' must be furnished along with the Tender documents unflinching.
- 4.2 The Earnest Money Deposit of unsuccessful tenderers will be refunded after finalization of the tender.
- 4.3 Earnest Money Deposit of the successful tenderer will be refunded on supply of indented boats.

5. TENDER VALIDITY :

The Tender shall remain valid till end of financial year 2018-19.

6. DELIVERY :

- 6.1 The FRP Boat, as per the specification has to be delivered after trials at concerned River Ghats within a period of 2 **(two) months from the date of issue of the order.**
- 6.2 The time frame for delivery is most important and should be strictly adhered to.
- 6.3 Delivery of Boat should be made at concerned river Ghats in good condition for which no extra cost will be paid towards loading, unloading and transportation.

7. PRICE :

- 7.1 A firm and fixed basic price should be quoted in a **separate sealed cover** for supply of the boat at different Ferry Ghats of Koraput.
- 7.2 The basic price quoted should be including of Goods & Service Tax (GST) & expenses for delivery at the site.
- 7.3 The details of GST payable as per government rules and transportation charges should be clearly mentioned in the delivery Challan as well as Bill Form.
- 7.4 Repair & maintenance charge of the Boat shall be quoted separately beyond the guarantee period and service of the supplier is mandatory to avoid future complicity.

8. SECURITY DEPOSIT :

- 8.1 Security Deposit @ 5 (five) per cent of the basic price will be deducted and kept from the payment which will be released after completion of the guarantee period.
- 8.2 No interest is payable for the Security Deposit.

9. INSPECTION & ACCEPTANCE :

- 9.1 Collector, Koraput or his authorised representative shall have the right to inspect the work at the construction site of the supplier for evaluation of quality and progress at various stages of work.
- 9.2 If during stage inspection, any defects are noticed, the supplier shall make good all necessary alterations/ rectifications needed as per the specified requirements for the boat.
- 9.3 The boat shall be finally accepted/ taken over by the Asst. Collector, Emergency, Collectorate, Koraput after inspection and running trials at concerned river Ghats.

10. GUARANTEE :

- 10.1 The supplier shall guarantee the performance of the boat, except the Engine (which will be covered by its manufacturer's warranty) for a period of one year from the date of delivery against all manufacturing defects.
- 10.2 Any manufacturing defects detected during the above said guarantee period shall be rectified free of cost by the supplier.

11. LIQUIDATED DAMAGES :

The work shall be completed within the stipulated delivery period, failing which liquidated damages for the delay @ Rs. 500/- (Rupees five hundred only) per day will be deducted from the contract value payable to the supplier and will be limited to a maximum of 5 (five) per cent of the basic value.

12. FORCE MAJEURE :

The supplier shall not be charged with any penalty nor shall his Security Deposit be forfeited, when failure in making delivery is due to any event beyond the control of the supplier and could not be foreseen, prevented or avoided. These include, but are not restricted to acts of government, acts of public enemy, fires, floods, epidemics, and such natural calamities of severe order and strikes/ lockouts.

13. DRAWING AND MANUFACTURE'S CERTIFICATE :

- 13.1 The successful tenderers will have to submit the complete General Arrangement Drawing lay-out of the FRP Boats to the Collector, Koraput or his authorised representative, before commencement of the construction work.
- 13.2 The supplier shall submit a manufacturer's certificate certifying the quality and workmanship of the Boat.

14. DOCUMENTS TO BE SUBMITTED ALONGWITH THE TENDER :

The following documents shall be submitted along with Tender for necessary evaluation.

- a) Proof of having at least 5 (Five) years experience in the manufacturing of FRP Passenger Boats.
- b) List of FRP Boats of lengths of 8.20 Mtr and above built and delivered to Govt./Public Sector/ and other reputed customers with particular experience of having built such type of boats.
- c) Registration Certificate from Industries Department and other such registrations.
- d) Valid GST registration No. / PAN Card.
- e) Any quality assurance certificate/ award obtained from reputed institution / firm.
- f) Drawing of FRP 20 Seater & 2 crew FRP boat as per the quoted specifications designed by a reputed Naval Architect.

1. **GENERAL :**

- a. The boat will be made of FRP (Fibreglass Reinforced Plastic) and will be designed and built for use as a 20 Seater & 2 crew FRP boat & Space for other materials.
- b. The bidder shall submit the drawing of FRP 20 Seater & 2 crew FRP boat as per the quoted specifications designed by a reputed Naval Architect.
- c. The successful bidder shall submit the design approved by IIT-Chennai before starting of construction work.

5. **CONSTRUCTION OF LAUNCH :**

a) **Hull :**

The boat hull will be made of FRP. (Fiberglass Reinforced Plastic) and pigmented to the desired colour as required. The hull is made of FRP with a time tested hull shape. The hull will have benches to accommodate 20 persons and space for other materials.

b) Adequate buoyancy will be provided as required.
