5. Validity of quotation:

Quotation shall remain valid for a period of not less than 60 days after the last date as specified in the quotation document.

6. Award of contract

6.1 The Purchase Order will be placed on the selected bidder (s) whose bid has been determined to be substantially responsive.

6.2 Purchase order will be placed to the supplier from time to time as per the requirement of DRDA, Koraput.

6.3 The bids are liable to be rejected if any of the above conditions are not complied with proper required documents.

6.4 Payment shall be made after delivery & installation of the goods through account transfer after submission of the bills and vouchers.

6.5 Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.

6.6 Any legal dispute arising out of this is subject to concerned district jurisdiction only.

6.7 Notwithstanding the above, the DRDA, Koraput reserves the right to accept or reject any Quotation and to cancel the bidding process and reject all bids at any time prior to the issue of contract letter. The bidders may be present in person or through one of their representative(s) during the opening of Quotations as per the date and time fixed by the Project Director, DRDA, Koraput.

6.8 The 1st Lowest Bidder cannot claim to supply the articles, as the articles will be purchased as per the specification, quality & requirement of DRDA Koraput.
