TERMS AND CONDITION

The Tender Paper can be obtained from the Block Development office, Semiliguda on payment of Cost of the tender paper (non refundable) in shape of cash. The tender paper will be sold from dt 10.12.2018 to 20.12.2018 on working days only from 10.00 AM to 3.00 PM in the office of the Panchayat Samiti Semiliguda. The sealed tender papers will be received on working days till 3.00PM of dt. 21.12.2018. The sealed tender papers should be submitted through Register/Speed Post addressed to BDO, Semiliguda. On the envelop it should be written "Tender Paper". The undersigned will not be held responsible for any delay in postal service. The Tender Papers received through postal service will be opened at 04.00 AM of dt.21.12.2018 in presence of Contractors or their authorized representatives.

The EMD is to be deposited in shape of NSC/KVP/Post Office Term Deposit / Deposit of any Nationalized Bank duly pledged in favour of Block Development Officer, Semiliguda.

The following documents should be furnished along with the tender papers failing which the tender is liable for rejection.

EMD duly pledged in favour of BDO, Semiliguda.

*Attested copy of the contractor Registration certificate.

*Attested copy of PAN Card

*Attested copy of GST clearance certificate.

*Attested copy of Caste Certificate for SC/ST contractor desirous of availing preference.


Attested copy of Labour License. (optional)

The Engineering contractor desirous of availing exemption of EMD should submit an affidavit to the effect that he has not availed exemption of EMD facility more than three times in the current financial year.

For tender quoting less rate from the amount put to tender, if his/her tender is considered to be accepted then the differential cost will be deposited by the contractor before agreement in shape of NSC/KVP/Bank TRD/Bank Draft/Banker cheque in favour of BDO, Semiliguda.

The Tenderer should not be quoted the tender beyond 15% less rate from the amount put to tender and not be excess from the amount put to tender. The EMD amount will be forfeited if the Tenderer backs out from the offer of acceptance of tender by the competent authority. The Tenderer has to show all required original documents at the time of opening of the tender for verification.

The Authority deserves all rights to reject or cancel any or all the tenders without assigning any reason thereof.
