
Block Development Officer, Laxmipur on behalf of Government of Odisha invites sealed tenders on percentage rate basis from registered contractors of PWD / WR/ RWD/ NH of Govt. of Odisha having registration for Civil works for execution of the following work under this Panchayat Samiti.

TERMS AND CONDITIONS

1. The tender documents will be sold in the office of the Block Development Officer, Laxmipur from **18.02.2019 to 26.02.2019** on working day only during working hours on payment of non refundable cost of tender paper in shape of demand draft in favour of B.D.O, Laxmipur in any Nationalised Bank.
2. The contractor must submit tender document for the works along with E.M.D. of the amount specified for the work in the table (Col.5) in shape of NSC / KVP/ Bank TDR duly pledged in favors of the Block Development Officer, Laxmipur and with attested copies of valid contractor registration certificate, ITCC, PAN Card & valid GSTIN No. in the office of B.D.O, Laxmipur.
3. Name of the work should be written in capital letter on the top of the cover containing the tender documents,
4. The tender papers will be received by Registered Post till 1.00 P.M of 25.02.2019 and will be opened on 26.02.2019 at 11.00 P.M. in presence of the contractors or their authorized representatives, who are requested to present. The undersigned will not be responsible for postal delay, tenders reached after the stipulated time will not be taken into consideration. Tender received in incomplete form and without any required document will not be considered.
5. The Engineer Contractors desirous of availing exemption of EMD should submit an affidavit declaring that he/she has not availed three nos. of EMD exemption during this current financial year 2018-19. SC/ST contractors desirous of availing preference should submit written application for the same with attested copy of valid caste certificate
6. **Additional Performance Security Deposit:** Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event only successful bidder who quoted less rates than the scheduled rate put to tender shall have to furnish the exact amount of differential cost. i.e. tender value minus the quoted amount as Additional Performance Security Deposit in shape of NSC / KVP/ Bank TDR duly pledged in favors of the Block Development Officer, Laxmipur within 03 (three) days otherwise the bid shall be cancelled and security deposit shall be forfeited further proceeding for black listing shall be initiated. (As per Govt. of Odisha Works Department office Memorandum No. 14299 dated 03.10.2017 and amendment of Para No. 3.5.5 (V) of OPWD code volume 1). **Any tender submitted with any fake document will be rejected and legal action will be initiated against the tendered.**

7. For tender quoting less rates beyond 7.5% from the amount put to tender, if his/her tender is considered to be accepted, he/she must submit the item wise analysis of rate in support of their quoted rate before agreement.
8. The successful tenderer will have to furnish the original valid contractor registration certificate, ITCC, PAN card & valid GSTIN number, Caste certificate for SC/ST for verification before agreement.
9. The work need to commence immediately after award of tender. Penalty of 3% of total tender value will be imposed if work does not commence within one week. The authority reserves the right to award the tender to L2 bidder (at L1 rate), if the work does not commence within two weeks of awarding the tender.
10. The authority reserves all right to reject any or all the tender without assigning any reason thereof.
