**TERMS & CONDITION:**

13) **Cost of Tender Paper:-** Tender documents for the individual work may be obtained from the Block Office, Pottangi as per annexure on payment towards cost of tender paper in shape of Bank Draft drawn in any Nationalized Bank in favour of Block Development Officer, Pottangi payable at State Bank of India, Pottangi .

14) **Sale of Tender Paper:-** Tender documents will be sold from 20.02.2019 to 26.02.2019 from 10.00 A.M to 5.00 P.M. in the Block Office (On Working days Only).

15) **Date of Receipt of Tender Paper:-** Sealed tender in complete shape will be received from 21.02.2019 to 26.02.2019 up to 5.00PM in the office of the Block Development Officer, Pottangi through Registered Post / Speed Post. Tender received by post after the stipulated date and time mentioned above will not be considered. Further that No tenders will be received by hand or by courier service (Working day only). The undersigned is not responsible for any Postal Delay.

16) **Date of Opening of the Tender Paper:-** The tender shall be opened on 27.02.2019 at 11.00 A.M in the office of the Block Development Officer, Pottangi in presence of the Bidders or their authorized representatives having written authorization for the purpose.

17) **Earnest Money Deposit:-** 1% (One Percent) of the Bid Value in shape of Post Office Pass Book / Post Office Term Deposit / Short Term Deposit / National Saving Certificate / Kisan Vikas Patra / Deposit Receipt of any nationalized bank/Post Office duly pledged in favour of Block Development Officer, Pottangi

18) **The following documents should be furnished with the Tender papers failing which the tender is liable for rejection:**

- i) Earnest Money Deposit pledged in favour of B.D.O. Pottangi
- ii) Attested copy of Contractor Registration Certificate.

- iii) Attested copy of PAN Card / VAT clearance certificate.
  - iv) Attested copy of Labour License.
  - v) The bidders have to produce an affidavit in support of the authenticity of documents including EMD etc attached with the tender paper.
  - vi) The Engineer contractors desirous of availing exemption of EMD should submit an affidavit as regards the fact of availing award of work without submission of EMD / ISD during the current financial year; otherwise their tender will be liable for rejection.
  - vii) The SC/.ST Contractors desirous of availing preference should submit an affidavit in support of caste certificate and Attested copy of Caste Certificate, otherwise their tender will be liable for rejection.
  - viii) Joint venture consortium agreements are not allowed to participate in tender.
- 19) **Additional Performance Security Deposit:-** Additional Performance Security shall be deposited by the successful bidder, where the bid amount is seriously unbalanced i.e., less than the estimated cost by more than 10%. In such case event the successful bidder will deposit the APSD amount to the extent of the differential cost of the bid amount and 90% of the estimated cost in shape of Post Office Pass Book / Post Office Term Deposit/ Short Term Deposit / National Saving Certificate / Kisan Vikas Patra / Deposit Receipt of any nationalized bank duly pledged in favour of Block Development Officer, Pottangi during drawl of agreement.
- 20) The tenderer quoting their rates less exceeding 7.5 % of the scheduled amount, they must have to submit their item wise analysis of rates in support of their quoted rates. Shortfall of any required documents, Drafts and EMD, tender paper is liable for rejection.
- 21) If the date of sale, receipt and opening of the tender as specified above happens to be holidays, then the process of sale, receipt and opening whatsoever will be shifted to immediate next working day at the same specified time and venue respectively without further notice.
- 22) The detail list of successful bidders against each work will be displayed in the notice board. The successful bidder will collect the letter of acceptance from the office of the undersigned within seven days from the date of declaration of list of successful bidders on the notice board in order to avoid postal delay for early execution of the work. No further claim will be entertained for non-receipt of acceptance letter.
- 23) The EMD amount is to be forfeited the tender backs out from the offer acceptance of tender by the competent authority.
- 24) The authority reserves the right to reject any or all the tenders without assigning any reason thereof.)
