
TERMS & CONDITIONS

1. Priority should be given for engagement of Jeep type Diesel Driven vehicle like Bolero/Marshal etc. For MVU.
2. The vehicle must be in road worthy condition and shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid permit, proof up to date tax payment etc which are mandatory for plying of vehicle.
3. The vehicle should accommodate minimum 3 persons.
4. A driver with valid license should be available as & when required. He should be a non-alcoholic, obedient and gentle in nature.
5. Vehicle should be kept clean and tidy condition and should have a clearly visible registration number in the vehicle.
6. Vehicle should be regularly serviced and maintained so as to avoid any break down. In case of break down an alternative vehicle should be immediately arranged by the owner without compromising the services of Mobile Veterinary Unit.
7. The vehicle must be stickered front, back & side displaying different flagship programme of the department as per Govt. guidelines.
8. In case of natural calamity like flood, cyclone, draught lightening. Heat waves etc. Out breaks on disease, Post Mortem of insured Livestock and other livestock emergency services, MVU should move to serve the livestock and to help poor farmers.

9. The vehicle owner disagree for installation of GPS tracking device will not be selected.
10. If 3yr old vehicle will not be available then vehicles within 5yr registration will be considered. In no case vehicle of more than 5yr old will be allowed.
