Bid documents consisting of plans specifications, schedule of quantities and a set of terms and conditions of contract and other necessary documents can be seen in the office of the undersigned during the office hours every day except Sundays and Public Holidays till the last date of sale and receipt of tender papers. Interest bidders may obtain further information at the same addresses.
3. Bids must be accompanied with Security/EMD of the amount specified for the work in Column No.5 of the above table, duly pledged in favour of the Block Development Officer, Jeypore, District- Koraput. Bid security will have to be in one of the forms as specified in the bidding documents i.e. NSC/KVP/TDR/STDR, Postal Saving Bank Account Passbook/Post Office Term Deposit/Term Deposit from any Nationalized Bank. The Bidders are required to submit attested copies of valid Contractor Registration Certificate, PAN Card, GST Clearance Certificate, Labour License, Experience Certificate otherwise his/her bid shall be declared as nonresponsive thus liable for rejection.
4. For a particular work a bidder can submit only one tender paper. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection of all such tenders.
5. The sale of Bid documents shall start from dt **16/12/2019** during office hours in the Office of the Block Development Officer, Jeypore and close on dt **30/12/2019** by **1.00 PM**.
6. Bid documents will be received during office hour up to **1.00 P.M.** on dt **31/12/2019** in the Block Office, Jeypore through **Registered Post/ Speed post** only. Receipt of bid documents after **1.00 P.M.** on dt **31/12/2019** will not be entertained. The authority is not responsible for in case of postal delay.
7. The bid will be opened on dt **31/12/2019** at **3.00 P.M.** in the office of the B.D.O., Jeypore in presence of the bidders or their authorized representatives who wish to attend. If the office happens to be close on the day of receipt and opening of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
8. Bid documents can be purchased during office hours from the office of undersigned by payment of cash/Demand Draft in any nationalized bank drawn in favour of Block Development Officer, Jeypore payable at IDBI Bank, Jeypore. The cost of bid document is a non-refundable fee towards cost of the documents as indicated under column -6 in the table.
9. If the bid amount is less than 15% of the tendered amount, then such a bid shall be rejected and considered as nonresponsive.
10. When the bid is up to 10% less than the estimated cost, no additional performance security is required to be deposited by the successful bidder. When the Bid amount is less than the estimated cost by more than 10% and within 15%, in such an event, the successful bidder will have to deposit the additional performance security to the extent of 1.50 times of the differential cost of the bid amount on 90% of the estimated cost in shape of NSC/ POTD /KVP/ Deposit receipt of Schedule Bank duly pledged in favour of the Block Development Officer, Jeypore, District- Koraput, in the sealed envelope along with the bid documents at the time of submission of Bids; otherwise the tender will not be accepted.
11. The bidders shall furnish an affidavit at the time of submission of bid, about the authentication of the tender documents including Registration Certificate, PAN Card, valid GST Clearance Certificate, Labour License, Experience Certificate and security etc.; failing which the bid shall be considered as non responsive and thus liable for rejection.
