



08. For contracts with stipulated completion period exceeding six months and up to 12 months period, the rates and prices quoted by the bidder shall be fixed and the Government will not entertain any claim towards escalation of rates.
09. The Project Administrator, I.T.D.A. Jeypore is the Authority reserves the right, even if qualifying criteria are met, the bidders can be disqualified for the following reasons i.e. (i)Past Record of Poor Performance (ii) Past Record of abandoning the work half way/ recession of contract (iii) Past Record of in-ordinate delay in start/completion of the work.
10. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or III.
11. Since the works are time bound programme, the successful tenderer have to furnish a declaration at the time of agreement to complete the work within the stipulated time period of stages of completion specified in Col. 04 of the above mentioned table. The ST/SC contractors willing to avail the facilities as fixed by Government will submit scan copy of the affidavit along with the **Copy Caste Certificate** for the same along with tender document and the original affidavit will be shown. **Otherwise they will not be entitled to avail such facilities and treated as General Category with evaluate the bid on its own merit.**
15. If the Rate Quoted by the SC and ST Category Contractors comes to 14.99% (Decimals up to two Numbers will be taken for all practical purpose) less than the estimated cost after availing 10% price preference as per Para-1 of Works Department Resolution No.27748, Dated.11.10.1977, the tender shall be finalized by the tender accepting authority through transparent lottery system alongwith other category of contractors whose rates are 14.99% less than the estimated cost in pursuance to the **Works Department Office Memorandum No.075569000162015-10224/W, Dated.01.09.2015.**
16. One Registered Cover should contain Tender Papers for **One Work Only** with mentioning the **Identification No, Name of Work alongwith Work Serial No** as well as the **Detail Postal Address of the bidder** on the body of cover. If tender papers (both separate cover and loose papers) for more than one work are found in a Single Registered Cover, then all the tender documents will be rejected.
