Sealed cover quotations in plain paper are invited from the Intending Nurseries / Private Growers/ Individual Farmer / NGOs / SHGs / Farm for supply of coffee seedlings to I.T.D.A, Koraput at concerned block headquarters of Koraput District, Odisha. The Intending Bidder / Suppliers should quote the rate per seedling which will include all taxes applicable by the Govt. as well as Transportation costs. The specification of the required material (Coffee seedlings) is given below which must be submitted by the bidder with the quotation.


The detail terms & conditions and list of required documents are available in the Website www.koraput.nic.in / **Office Notice Board** which can be uploaded. The quotation alongwith the photocopies of the required documents should reach to the Office of undersigned between 29.07.2021 to 11.08.2021 (Upto 2.00 PM) (Through Registered Post/ Speed Post / Courier) only, which will be opened on 11.08.2021 at 3.00 PM by the Tender Committee in the office of the PA, I.T.D.A, Koraput.

Required documents :

1. Identification of the Bidder any one (Voter ID/ Aadhar Card/ PAN/ Driving License/ Bank Account No.).
2. Experience Certificate if any of supply of Coffee seedlings earlier.
3. Details of the availability of seedlings i.e. Address of the location/ Nos. available & Variety.
4. GST Certificate / Sale Tax / Income Tax Returns.
5. Xerox Copy of first page of Bank Account Pass Book.

Terms & Conditions

1. The cover containing the quotation should be superscribed "QUOTATION FOR THE SUPPLY OF COFFEE SEEDLINGS". EMD of Rs.5000/- (Rupees Five Thousand) only should be remitted through DD alongwith quotation in favour of PA, I.T.D.A, Koraput, Odisha.
2. The bidder should submit their bids with Xerox copy of sale license, valid GSTN Certificate with update returns of GST Payments, Income Tax Returns of last 2 years along with the quotation. Original documents should be produced before the committee at the time of opening of bid. If any bidder fails to submit the required documents, the same will be decided by the Committee.
3. The Bidder must replace and supply the quantity for the defective coffee seedlings supplied by him at his own cost.
4. The rate should be quoted per seedling including transportation and other taxes as applicable to I.T.D.A, Koraput.
5. Time of completion for the work is fifteen days from the date of Work Order issued.
6. The coffee seedlings should have been raised from certified seeds/ proper seeds of Arabica variety only.
7. The seedlings should be disease free, healthy having 5-6 pairs of leaves during the time of supply.
8. The seedlings raised in polythene bags of minimum 5" x 9" size and above.
9. The rates quoted must includes the GST, other Taxes, Transportations etc. for supply at the concerned block headquarters (Nandapur, Lamtaput, Koraput, Semiliguda, Dasamantapur & Laxmipur).
10. Payments will be made after joint verification by the Technical Committee comprising of officers from SLO, Coffee Board, PA, I.T.D.A, Koraput & Dy. Director, Coffee Development, Koraput.
11. The Committee may verify / check the seedlings of the successful bidders at the nursery / available sites if needed.
12. The authority reserves the right to reject any or all quotations without assigning any reason thereof.
