TENDER CALL NOTICE

The Block Development Officer, Laxmipur invites percentage rate (%) sealed tenders in conformity with the **Tender Call Notice (TCN)** from the registered contractors of **State PWD / M.I / Irrigation / Rural works / CPWD / PHD** for the following works under Laxmipur Block to be eventually drawn in **PWD P-1 / F-2** agreement as detailed below. The amount put to tender and bid security may be changed and confirmed at the time of selling of tender documents.

TERMS AND CONDITIONS: -

- 1) The details of work including the **estimated cost, tender value, EMD, required class of contractor, completion time, cost of tender paper, place of selling of tender paper etc.** are available in the website '<http://www.drdakoraput.org>' or '<http://www.koraput.nic.in>'. The bidders have to deposit required amount toward cost of the tender.
- 2) Tender documents for the individual work may be obtained from the office of the Block Development Officer, Laxmipur on payment of cost (**non-refundable**) of the tender paper in shape of **Bank Draft/Bankers cheque** drawn on any nationalised bank in favour of Block Development Officer, Laxmipur.

- 3) The tender papers will be sold from **25.08.2021 to 13.09.2021(working days only)** up to **5:00 PM** in the office of the **Panchayat Samiti, Laxmipur**. Sealed tender papers will be received from **25.08.2021 to 13.09.2021 up to 5:00 PM** on working days only in the office of Panchayat Samiti, Laxmipur through **Registered post/Speed post** only. The tender papers received after stipulated date and time will not be considered. No tender papers will be received **by hand or by courier service**. The tender papers shall be opened on **14.09.2021 at 11.00 A.M (Tuesday)** onwards in the **office chamber of Block Development Officer, Laxmipur** in presence of the bidders or their authorised representatives having written authorization for the purpose.
- 4) **All documents should be self-attested.**
- 5) The following documents should be furnished along with the tender papers failing which the tender is liable for rejection.
 - a) **EMD** duly pledged in favour of **Block Development Officer, Laxmipur**
 - b) **Money receipt** of TCN shall be enclosed in original.
 - c) **No relation certificate with any committee members** should be furnished.
 - d) Self-attested copy of the **contractor registration certificate**
 - e) Signed copy of **TCN and Tender Schedule** duly filled and signed by the tenderer
 - f) Self-attested copy of **PAN cards and Valid GSTIN, GST Reg. Certificate/ITCC**
 - g) An **affidavit** in support of the authenticity of the documents including EMD should be attached with tender paper.
 - h) The **Engineering contractor** desirous of availing exemption of EMD should submit an **affidavit** to the effect that he has not availed exemption of EMD facility more than three times in the current financial year.
 - i) **SC/ST contractor** desirous of availing price preference over General category contractors should submit an **affidavit in support of caste certificate and attested copy of recent caste certificate (within one year for other than SC/ST)**.
 - j) **Any contractor submitted with any fake document will be rejected and legal action will be initiated against the tenderer.**
- 6) Contractors with prior experience may furnish documents to show past performance.
- 7) Bidders should furnish EMD of appropriate value as per **Column-5** against the particular work only in shape of a separate **Demand Draft/NSC/KVP/TDR/STDR/Post Office Saving Bank Account/Post Office term Deposit/Term deposit from any Nationalized Bank** duly pledged in favour of the "Block Development Officer, Laxmipur". One EMD should be made for one work only. Separate EMD should be made for separate work. In no case one EMD should be utilized for more than one work.
- 8) **Addl. Performance security** shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as **Additional Performance Security (APS) in shape of Demand Draft/ Term Deposit Receipt** pledged by the contractor **before agreement** in favour of the **Block Development Officer, Laxmipur** otherwise **the bid shall be cancelled and the Security deposit shall be forfeited**. Further, proceeding for blacklisting shall be initiated against bidder as per works department office memorandum No.14299, dated 03.10.2017.
- 9) **All the tenders where rate quoted is '15% and above' than the scheduled rate will be rejected.**
- 10) The detailed list of successful bidders against each work will be displayed in the notice board. The successful bidders will collect the letter of acceptance from the office of the undersigned within **seven days from the date of declaration of list of successful bidders** on the notice board in order to avoid postal delay for early execution of the work. No further claim will be entertained for non-receipt of the acceptance letter.

- 11) The EMD amount is to be forfeited if the successful tenderer backs out/ refuses from the offer of acceptance of tender by the competent authority. EMD shall also be forfeited if the tenderer withdraws his/her bid during the tender period.
- 12) The cover containing the tender paper should be super scribed at the top "**Tender work for Panchayat Samiti, Laxmipur**" or the **Name of the work should be mentioned clearly** otherwise the cover will not be opened for consideration.
- 13) The tender papers will be received through **Registered post/ Speed Post** only. No tenders will be received **by hand or by courier services**. The undersigned will not be held responsible for any delay in postal service.
- 14) In case of shortfall of any required documents, the tender papers are liable for rejection.
- 15) Since the works are time bound programme, the tenderers have to complete the same within the specified time, failing which; penalty of 10% will be imposed as per OPWD code.
- 16) Provisions of OPWD code as well as instructions and guidelines of Govt. of Odisha are applicable.
- 17) The tenderer has to show **his original documents (Contractor license, PAN card, Valid GSTIN, GST certificate, ITCC, Caste Certificate in case of SC/ST/Engineering contractor license (for engineering contractor etc.) at the time of opening of the tender papers.**
- 18) The quoted percentage rate should be mentioned clearly in **figures and in words**.
- 19) The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
