
At the outset, the District Employment Officer, Koraput presented all 07(Seven) sealed covers of quotations received in due time from the bidders as annexed at Annexure-I and one late bid, which has been received after the stipulated time. The representatives of the bidders objected to open the bid which has been received after the stipulated time and hence the selection committee decided against opening the late bid. Other 07(Seven) bids which were received in time are opened in the presence of all the members and representatives of the bidders present.

After thorough technical evaluation of all eligible bids submitted by each bidder, a comparative statement has been prepared and placed at Annexure-I.

Having gone through the Technical bids submitted by the bidders, it is observed that no bidder has submitted satisfactory documents for all the parameters.

As such the Committee has unanimously decided not to proceed and hence cancel the bidding process and to re-invite fresh bids through Expression of Interest for empanelment of Training Service Provider for undertaking placement linked training programme for youths of Koraput district to be published later.


