





TERMS AND CONDITIONS


1. Those tenderers who have not submitted required documents with the bid they are automatically disqualified and cannot claim future.
2. The hotel should be situated in municipality jurisdiction of Jeypore.
3. The hotel should be registered under Good & Service Tax.
4. The hotel should have valid trade license.
5. The hotel should have filed I.T return for the F.Y-2019-20. There is no need to submit the IT returns those have functioning in this year.
6. The hotel should have own laundry facility for washing, drying and ironing. The bed sheet, pillow cover & towel of each room must be changed regularly.
7. Tender must be accompanied by Tender document Cost of Rs.1180/- (Non refundable) and EMD of Rs.25000/- (Rupees Twenty five Thousand only) in technical bid by way of demand draft, drawn on State Bank of India (SBI) in favour of the **ROGI KALYAN SAMITI D H H KORAPUT**. Tenders not accompanied by tender document cost & EMD will not be considered. EMD of unsuccessful tenders will be returned without interest on finalization of bid. EMD of successful tender will be retained & will be refunded on successful completion of the contract without interest.

10. The Hotels with in one (01) Km radius or at a walk able distance from district headquarters hospitals will be given priority as the trainees and trainers cannot be provided with additional transport.
11. In case any hotel will be providing the transportation facility to the accommodate persons from hotel to district headquarters hospitals, koraput at jeypore within the room rent then above condition will be treated as par with Sl.no.9.
12. Proper hygiene should be maintained and basic facilities like 24*7 water including hot water provision, sufficient Drinking water facility, Security service, and uninterrupted power supply must be ensured along with TV with cable facility and Table with chair for study purpose at each room.

14. The award will be given to L1 bidder who quote rate excluding GST subject to fulfilling all the conditionality.


