



5. Bid document/application without tender document cost will be summarily rejected.
6. Bidders will have to submit following documents in order to qualify for the auction sale:
 - A. Photo copy of PAN Card.
 - B. Photo copy of AADHAAR Card.
 - C. Photo copy of GST registration certificate (if available).
 - D. Photo copy of last GST return filed (for registered parties).
 - E. Tender document cost of **Rs. 1,000/- (Rupees One Thousand only)** (non-refundable).
7. Auction will be held on "AS IS & WHERE IS BASIS".
8. Highest bidder will be given preference for receiving auctioned vehicles.
9. **Both registered and unregistered Bidder will have to bear GST as applicable on auction sale of ambulances. GST @ 18% applicable on auction price.**
10. The successful bidder shall get the vehicles transferred as per rule and only after submission of full price finalized as per auction. The bidder will have to deposit the full amount including GST (as applicable) either in shape of Bank Draft or have to deposit cash in ZSS (Non - NRHM funds), Koraput having **Savings Bank account no: 30249233315** and produce deposit slip as a proof for payment of full auction price of ambulances. There after bidder will be allowed to remove the vehicles.

12. ***The highest bidder will have to remove the vehicle at his own cost within 7 days, failing which parking charges shall be levied @ 1% of the bid value per day. No conditional offer shall be entertained.***
13. Other term & conditions shall be declared at the spot during the auction.
14. If there is any contradiction between price quoted in figure and word then price quoted in word shall prevail over price quoted in figure.
