



Sub: Restriction of access to ERONet system from whitelisted IP addresses. Reg.
Sir/Madam,

In order to strengthen the security of ERONET system, it has been directed to implement the restriction of access to ERONet system from whitelisted IP addresses only by 15 September 2021. The whitelisting of IP addresses require fixed IP address(es) from where the system is being accessed. This requires either Internet leased line or Broadband/FTTH connection with Fixed IP address. The ERONET systems are being primarily accessed from office of CEOs, DEOs, EROS & ASROs and all offices may not have fixed IP connectivity at present. It is observed ISP's tariff plan that approx. Rs 2000 per annum may be the additional cost for one fixed IP address per Broadband/FTTH connection.

CEOs are requested to collect the detail of fixed IP addresses from all AEROS/ EROS/ DEOs through DEOs and inform to BCI/CDAC to whitelist same for access of ERONET before 15th September 2021. In case of non-availability of Fixed IP connection with any office, CEOs may instruct the concerned officer to convert their connection with fixed IP plan within by 14th September 2021 and inform same to BCI /CDAC so that there will not be any issue in accessing the ERONET otherwise it would not be accessible.

The whitelisting of IP addresses requires internet leased line or broadband /FTTH connection with fixed IP address(es) from where the system is being accessed.

In Odisha data entry of forms is being done by the Computer Firms selected through decentralized selection process. As per the Request for Proposals invited vide RFP No.4904/Elec. dt.21.08.2021. The General /Technical Bid of the Tender is scheduled to be opened on 14th Sept, 2021 and opening of Financial Bid is scheduled on 16th September, 2021. As per the tender condition at Annexure-I-A, the bidder will ensure establishment of operation centre(s) at the Sub-Divisional Headquarters with the availability of prescribed infrastructure and dedicated manpower before signing of the agreement to execute the RFP related works.


By the time of floating of the tender the concept of whitelisted IP address was not introduced by Election Commission of India therefore this was not mentioned in the Request for Proposal invited vide RFP No. 4904/Elec. dt. 21.08.2021. As whitelisted IP address has been made mandatory by the Commission this needs to be accommodated in the RFP. Accordingly, an addendum has been added to the RFP No. 4904/Elec. dt. 21.08.2021 a copy of which is enclosed for ready reference.
