

**TERMS & CONDITIONS -**

1. The details of work including the estimated cost, Tender value, EMD, required class of contractor, completion time, cost of tender paper, place of selling to tender paper etc. are available in the website//[www.drdakoraput.org](http://www.drdakoraput.org)//[www.koraput.nic.in](http://www.koraput.nic.in). The bidder has to deposit required amount towards cost of the tender.
2. Tender documents for the individual work may be obtained from the office of the Block Development Officer, Dasmantpur on payment of cost (non refundable) of the tender paper in shape of Bank Draft/Banker cheque drawn on any nationalized bank in favour of Block Development Officer, Dasmantpur.
3. The tender papers will be sold from 28/10/2021 to 03/11/2021 (Working days only) up to 5.30 PM in the office of the Panchayat Samiti, Dasmantpur. Sealed tender papers will be received from 28/10/2021 to 03/11/2021 upto 5.30 PM on working days only in the office of Panchayat Samiti, Dasmantpur through registered post/speed post only. The tender papers received after the stipulated date and time will not be considered. No tender papers will be received by hand or by courier service. The tender papers shall be opened on 06/11/2021 at 11.00 A.M. onwards in the Office chamber of Block Development Officer, Dasmantpur in presence of the bidders or their authorized representatives having written authorization for the purpose.
4. All documents should be self-attested failing which the tender is liable for rejection.
5. The following documents should be furnished along with the tender papers failing which the tender is liable for rejection.
  - a) EMD duly pledged in favour of Block Development Officer, Dasmantpur.
  - b) Money Receipt of TCN shall be enclosed original
  - c) No relation certificate to the Block Development Officer
  - d) Signed copy of TCN and Price-bid duly filled and signed by the tenderer

- e) Self-attested copy of PAN cards and GSTIN,GST Reg.Certificate
  - f) An affidavit in support of the authenticity of the documents including EMD should be attached with tender paper.
  - g) **The Engineer contractor** desirous of availing exemption of EMD should submit an **affidavit** to the effect that he/she has not availed exemption of EMD facility more that three times in the current financial year.
  - h) **SC/ST contractor** desirous of availing price preference over General category contractors should submit an **affidavit in support of caste certificate and attested copy of recent caste certificate.**
6. The bidder should submit the Past performance of the contractor. (**Experience certificate of Similar nature of work**)
  7. Bidder should furnish EMD of appropriate value as per **col.4** against the work in shape of **Demand Draft/NSC/KVP/TDR/STDR/Post office saving Bank Account/Post Office term deposit/Term deposit from any Nationalized Bank** duly pledge in favour of "Block development Officer,Dasamantpur"
  8. Addl. Performance security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates that the estimated cost put to tender minus the quoted amount as Additional Performance Security(PAS) in shape of Demand Draft/Term Deposit Receipt pledged by Contractor before agreement in favour of the Block development Officer,Dasamantpur otherwise the bid shall be cancelled and the security deposit shall be forfeited.Further ,proceeding for blacklisting shall be initiated against bidder as per works department office memorandum No-14299 dated-03-10-2017.
  9. **All the tenders where rate quoted is "15%" and above the scheduled rate will be rejected.**
  10. The detailed list of successful bidders against each work will be displayed in the notice board. The successful bidders will collect the letter of acceptance from the office of the undersigned within seven days from the date of declaration of list of successful bidders on the notice board in order to avoid postal delay for early execution of the work. No further claim will be entertained for non-receipt of the acceptance letter.
  11. The EMD amount is to be forfeited if the successful tender backs out/refuse from the offer of acceptance of tender by the competent authority.EMD shall also be forfeited if the tenderer withdraws his/her bid during the tender period.
  12. The cover containing the tender paper should be super scribed the top" Tender work for Panchayat Samiti,Dasamantpur" or the Name of the work should be mentioned clearly.
  13. The tender paper will be received through **Registered post/Sped Post** only. No tender will be received by hand or by Courier services. The undersigned will not be held responsible for any delay in postal service.
  14. In case of short fall of any required documents, the tender paper is liable for rejection.
  15. Since work is time bound programme, the tenderers have to complete the same within the specified time, failing which; penalty of 10 % will be imposed as per OPWD code.
  16. Provision of OPWD codes as well as instruction and guidelines of Govt. of Odisha are applicable.
  17. The tenderers are to show his original documents(Contractor license, PAN card,GSTIN,GST certificate, Caste Certificate in case of SC/ST/Engineering contractor etc.) at the time of opening of tender papers.
  18. The quoted percentage rate should be mentioned clearly in **figure and words.**
  19. The authority reserve the right to reject any or all the tenders without assigning any reason thereof.
