3. Eligibility Criteria of the Bidder:

3.1. Quotation received late and incomplete will not be considered.

3.2. The prices quoted should be inclusive of all taxes, transportation cost and ancillary cost. Each Bidder shall submit only one quotation at a time. Final price is negotiable.

4. Validity of quotation:

Quotation shall remain valid for a period of not less than 60 days after the last date as specified in the quotation document.

5. Selection Approach:

Selection & Finalization of “Logo” shall be done under the Chairmanship of Collector, Koraput, based on the preferences of District Council of Culture.

6. Award of contract:

6.1 The Work Order will be placed on the selected bidder (s) whose bid has been determined to be substantially responsive.

6.2 The bids are liable to be rejected if any of the above conditions are not complied with proper required documents.

6.3 Payment shall be made through account transfer (RTGS) after submission of the authentic bills and vouchers, verified by the undersigned.

6.4 Any effort by a bidder to influence the tendering agency in its decision on bid evaluation or placement of work order may result in rejection of the bidder's offer.

6.5 Any legal dispute arising out of this is subject to concerned district jurisdiction only.

6.6 Notwithstanding the above, the Collector & DM Koraput, reserves the right to accept or reject any Quotation and to cancel the bidding process and reject all bids at any time prior to the issue of contract letter. The bidders may be present in person or through one of their representative(s) during the opening of Quotations as per the date and time fixed by the Project Director, DRDA, Koraput.
