The quotation should reach at the Office of the Manager Poultry Breeding Farm, Semiliguda Koraput by Dt.10.11.2021 on or before 5 PM & will be opened in the presence of the members of the District Technical Committee at 11 AM on Dt.11.11.2021. The quotationer or their representatives may remain present at the time of opening the quotation failing which no complain or disputes in future shall be entertained. The District Technical Committee reserve right to accept or cancel even if found lowest without assigning any reason thereof.

The rate should be quoted in the prescribed box against each item.

CONDITIONS

1) Price Basis:- Rates to be quoted are inclusive of all taxes & duties, net weight, packing, forwarding, loading & unloading and freight up to Office of the Manager Poultry Breeding Farm, Semiliguda Koraput.

2) Documents Required:- Copy of Income Tax/GST clearance certificate must be attached with quotation.

3) Issue of Order:- The Purchase Order will be issued to the quotationer after finalisation & approved by the District Technical Committee.

4) Supply of Ingredients:- The approved ingredients should be supplied to Manager Poultry Breeding Farm, Semiliguda Koraput as per the requirement of the farm in the difference of 14 days as desired by the authority.

5) Quality of Ingredients:- Ingredients should be fresh, free from adulterants, insects, fungus, infestation, rancidity and undesirable & objectionable odours. It should also be free from dirt and extraneous matter including iron and metallic pieces.

6) Delivery of Ingredients:-The ingredients should be delivered at Manager Poultry Breeding Farm, Semiliguda Koraput within 3 days of indent.

7) Payment:- Payment will be given after supply of ingredients with maintaining all formalities. It will be given in shape of A/C payee cheque. Any deviation in quality & quantity of ingredients will subjected to deduction as decided by the District Technical Committee.

8)Duration of Quotation:- The duration of the quotation will be valid till rate of ingredient reach Rs. 1,00,000/- (Rupees one lakh)only or a time period of six month which is earlier.


9) If the lowest quoted rate coincides, then local supplier will be given preference.


