SHORT TENDER CALL NOTICE

The Block Development Officer, Semiliguda on behalf of Governor of Odisha invites sealed tenders on percentage (%) rate basis from registered Contractors of Odisha PWD/WR/RWD/NH/MI/CPWD for the following works in conformity with the detail tender call notice.

TERMS AND CONDITION

1. The amount put to tender as per column-4 of the above are excluding GST.
2. The Tender Paper can be obtained from the Block Development office, Semiliguda on payment of Cost of the tender paper (non refundable) in shape of Demand Draft payable in favour of Block Development officer, Semiliguda. The tender paper will be sold from **Dated:10.12.21 to 19.12.21 on working days only from 10 AM to 05.30 PM** in the office of the Panchayat Samiti Semiliguda. The sealed tender papers will be received on working days till **03.00 PM of dt:20.12.21** The sealed tender papers should be submitted through Register/Speed Post addressed to BDO, Semiliguda. The name of the work for which the Tender Paper has submitted should be mentioned over the Envelop. The undersigned will not be held responsible for any delay in postal service. The Tender Papers received through postal service will be opened at **4.00 PM of Dated:20.12.21** in presence of Contractors or their authorized representatives.
3. Bidders should furnish EMD of appropriate value as per column-4 against the particular work only in shape of NSC/KVP/Post Office Term Deposit / Term Deposit Receipt from any Nationalised Bank duly pledged in favour of the "**Block Development Officer, Semiliguda**". One EMD should be made for one work only. In no case one EMD should be utilized for more than one work. The Demand Draft/Bankers Cheque will not be entertained and liable for rejection.
4. The successful bidder, whose tender accepted is required to deposit at the time of acceptance of tender one percent of the Tender value equivalent to the amount of EMD of appropriate value as per column-4 against the particular work in shape of NSC/KVP/Post Office Term Deposit / Term Deposit Receipt of any Nationalized Bank duly pledged in favour of Block Development Officer, Semiliguda.
5. The following documents should be furnished along with the tender papers failing which the tender is liable for rejection.

- *EMD duly pledged in favour of BDO, Semiliguda.
- *Self Attested copy of the contractor Registration certificate.
- *Self Attested copy of PAN Card
- *Self Attested copy of GST Registration Certificate
- *Self Attested copy of GST clearance certificate.
- * Affidavit of No relation Certificate
- * Affidavit about authentication of documents submitted

6. SC/ST contractors desirous of availing price preference over General category Contractors should submit an affidavit in support of caste certificate and attested copy of recent Caste certificate.

7. The Engineer contractor desirous of availing exemption of EMD should submit an affidavit to the effect that he has not availed exemption of EMD facility more than three times in the current financial year.

8. For a particular work a bidder can submit only one tender paper. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection of all such tenders.

9. The bidder shall furnish an affidavit at the time of submission of bid about the authentication of the tender documents including the above required documents failing which the bid shall be considered as non-responsive and thus will be liable for rejection.

10. For tender quoting less rate from the amount put to tender, if his/her tender is considered to be accepted then the differential cost will be deposited by the contractor before agreement in shape of NSC/KVP/Bank TDR in favour of BDO, Semiliguda.

11. If any bidder quotes less than 15% (Fifteen) or more of the amount put to tender then such bid shall be rejected and the tender shall be finalized basing on merit of the rest bids and if more than one bid is quoted 14.99% (decimal up to 2 digits will be taken for all purposes) less than the estimated cost the tender accepting authority will finalise the tender through transparent lottery system in presence of bidder or their authorized representative.

12. The percentage rate should clearly mentioned both in figure and in words. Any discrepancy if found then the rate mentioned in words will be taken as final rate.

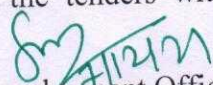
13. Percentage quoted in the tender without mentioning less or excess then it will be treated as excess.

14. Validity of tender shall be 90 days from the date of opening of tender.

15. The EMD amount will be forfeited if the Tenderer backs out from the offer of acceptance of tender by the competent authority. The Tenderer has to produce all required original documents at the time of opening of the tender for verification.

16. The detail successful bidders will be notified in the Office notice board of Block Office, Semiliguda.

The Authority reserves all rights to reject or cancel any or all the tenders without assigning any reason thereof.
