2. The contractor must submit tender document for the works along with E.M.D. of the amount specified for the work in the table (Col.5) in shape of NSC /KVP/Bank TDR duly pledged in favour of the Block Development Officer, Nandapur and with attested copies of valid contractor Registration certificate, ITCC, Pan Card, & valid GSTIN no. upto November 2021 (Obtain GST clearance certificate) in the Block Office of Nandapur.
3. Name of the work should be written in capital letter on the top of the cover containing the tender documents.
4. The contractor has to mention percentage excess or less over the estimated cost (in figure & words).
5. In percentage rate of tender only percentage quoted shall be considered. Percentage quoted by the contractor shall be accurately filled in figure & words, so that there is no discrepancy, if any discrepancy is found in the percentage quoted in words and figures then percentage quoted by the contractor in words shall be

taken as correct. If excess / less is not mentioned, then the rate will be treated as percentage excess

6. The default maintenance period is 02 year from the date of issue of work completion certificate. Contractor is responsible for any defective work or leakage of slab. Re-construction of defective work or leakage of slab shall be completed by the Contractor in his own cost.
7. The tender paper will be received by registered post/Speed post only till 4.00 PM of 22.12.2021 and will be opened on 23.12.2021 at 11.00 A.M in presence of the contractors or their authorized representatives, who are requested to present. The undersigned will not be responsible for any delay, tender reached after the stipulated time will not be taken into consideration. Tender received in incomplete form and without any required document will not be considered.
8. The engineer contractors desirous of availing exemption of EMD should submit an affidavit declaring that he / she has not availed three nos. of EMD exemption during this current financial year 2021-22. SC/ST contractors desirous of availing preference should submit written application for the same with attested copy of valid caste certificate.
9. Additional Performance Security deposit: Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event only successful bidder who quoted less rates than the scheduled rate put to tender shall have to furnish the exact amount of differential cost. i.e. tender value minus the quoted amount as additional performance security Deposit in shape of NSC/KVP/Bank TDR duly pledge infavour of the Block Development Officer , Nandapur within three days otherwise the bid shall be cancelled and security deposit shall be forfeited further proceeding for black listing shall be initiated . (As per Govt. of Odisha works department office Memorandum No. 14299 dated. 03.10.2017 and amendment of Para No. 3.5.5 (V) of OPWD code volume 1). Any tender submitted with any fake document will be rejected and legal action will be initiated against the tendered. The successful Bidder to deposit the APS amount as per the following.
