
**FIRST CORRIGENDUM TO TENDER CALL NOTICE NO. 2/2021-22**

As per the Office Memorandum No. 5984/W, dtd. 27.04.2021 of Government of Odisha, Works Department, there is no need to deposit Bid Security/EMD along with the bid documents. Bidders are required to submit "Bid Declaration" along with the bid documents.

Accordingly, there is no need to deposit EMD of Rs.31,300/- in the present tender (Tender Call Notice No. 2/2021-22). Bidders are required to submit "Bid Security Declaration" in lieu of Bid Security with stipulation that if they withdraw or modify their bids during period of validity etc., they will be suspended for the time specified in the tender documents. Bidders are required to submit "Bid Security Declaration" in the format vide Annexure-III.

Successful bidders has to furnish 2% of the tender value towards EMD & ISD in shape of a separate Demand Draft/NSC/KVP/TDR/STDR/ Post Office Saving Bank Account/Post Office Term Deposit/Term Deposit from any Nationalized Bank duly pledged in favour of the "**Block Development Officer, Boipariguda, District- Koraput**".
