Sealed tenders are invited in Notice Board from the intending persons for auction sale and disposal of one old Diesel Jeep Mahindra and Mahindra four wheel drive in "AS IS WHERE IS BASIS" bearing Registration No. OR-10-4045 of the Assistant Registrar of Cooperative Societies, Koraput Circle, Koraput District – Koraput. The upset price of the vehicle has been fixed to Rs. 35000/- (Rupees Thirty five Thousand) only by the competent authority. The intending tenders are required to submit their tender in scaled cover by Registered post along with earnest money of Rs. 1000/- (Rupees One Thousand) only in shape of bank draft in favour of Assistant Registrar of Cooperative Societies, Koraput Circle, Koraput. The earnest money deposit will be refunded to the un-successful tenders after finalization of the sealed tender. But no interest will be paid. Tender without bank draft will not be entertained. The tenders are required to state their full name, present address, No & date of Bank draft and the price offered for the vehicle in the tender and write "TENDER FOR THE VEHICLE" on the top of the cover. The offered price below the upset price fixed by the competent authority will not be accepted. Tender will be received by the Assistant Registrar of Cooperative Societies, Koraput Circle, Koraput up to dt. 17.03.2022 and will be opened on dt. 21.03.2022 at 11.A:M in presence of the tenders or their authorized representatives. The intending tenders can inspect the vehicle at office premises of Assistant Registrar of Cooperative Societies, Koraput Circle, Koraput, during the Office hours on any working day and get detail information from the Assistant Registrar of Cooperative Societies, Koraput Circle, Koraput, before submitting the tender. The tender whose tender will be accepted will have to deposit 25% of the tendered amount on the spot and the rest 75% within seven days from the date of conformation of the tender, failing which the 25% of the tendered value and the earnest money deposited will be forfeited. The vehicle should be removed from the site within seven days after depositing the tender amount in full and Orders are passed to that effect, custody and safeguard of the vehicle, if not lifted within the stipulated time as stated above, shall be responsibility of the tender and no claim or complain on the matter shall be entertained and ground rent at the rate of 1% of the tendered amount will be charged for each day or part of the day till removal of the vehicle from the site, spare parts and fuel implements will not be delivered with the vehicle. The authority reserves all right to accept or reject any or whole of the tenders and cancel or extend the date of auction without assigning any reason thereof.
