

2. The Bid documents will be available in the website www.tendersodisha.gov.in/www.odishaforest.in/www.koraput.nic.in from 11.00 Hours of Dt 29.08.2022 to 16.00 Hours of Dt 12.09.2022 for online bidding.
3. The Bidders must process Compatible Digital Signature Certificate (DSC) of Class C.
4. The Bids must be received only "On-line" on or before 16.00 Hours of Dt 12.09.2022.
5. The Bids received "On line "shall be opened at 11.00 Hours on **Dt 13.09.2022** in the office of the Divisional Forest Officer, Jeypore Forest Division, Jeypore in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
6. The cost of Bid documents in shape of demand draft / bankers cheque issued from post office pledged and any Nationalized commercial Bank may be prepared in the name of Divisional Forest Officer, Jeypore Forest Division mentioned under column no 6 above payable of Jeypore separately i.e. towards paper cost for each Bid respectively.
7. Additional performance security shall be given from the Bidder when the Bid amount less than estimated cost put to tender. In such an event only the successful Bidder who has quoted less Bid price rates than the estimated cost put to tender shall have to furnish the exact amount of different cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand Draft / Term Deposit received pledged in favour of Divisional Forest Officer, Jeypore Forest division within Seven (7) days otherwise Bid shall be cancelled and the security deposit shall be forfeited. Further proceeding for black listing shall be initiated against the bidder.
8. The bidder shall have to furnish a bid security declaration as per the Finance Department, Government of Odisha in lieu of Bid Security in the format annexed form of Bid security Declaration along with the bid.
9. Other details can be seen in the bidding documents.
10. The authority will not be held responsible for any technical issue or network failure during online bidding.
11. The authority reserves the right to cancel any or all bids without assigning any reason thereof.
