1. The envelop carrying the bid must be subscribed in capital letters " **OFFER FOR AUCTION SALE OF GOVT. JEEP BEARING REGISTRATION NO. _____** " Bid for auction sale of each Govt. Jeep shall furnish separately with the information like Name of the Participants, Present address, mobile No., details of EMD and bid amount clearly mentioning in words and figures with signature of the participants.
2. The intending tenderers are advised to inspect the above vehicle parked at place mentioned above between 11.00 AM to 05.00 PM from the date of publication of this notice to 12.09.2022 on all working days before submitting the tender. Each tender must accompany an earnest money deposit of ₹.1,000/- (one thousand) only for each Govt. Jeep in shape of Bank Draft drawn in favour of the Deputy Director, Coffee Development, Koraput payable at SBI, Koraput which will be refunded to the tenderers whose tenders are not accepted except in case of the successful bidder.
3. The tender should reach the undersigned by registered post/ speed post or by hand on or before 12.09.2022 up to 5.30 PM at the latest and tenders received till then shall be opened on the **next** date i.e. 13.09.2022 at 11.00 AM by the tender committee in the office chamber of Deputy Director, Coffee Development, Koraput in the presence of the tenderers or their authorized representatives. If this day is declared later as a Government holiday then the tenders will be received and opened on the next working day as per the schedule time. The undersigned will not be held responsible regarding late submission/ receive of tender in any manner.
4. The highest tenderer, whose tender is accepted, shall have to deposit immediately 25% of the offered amount then & there as initial deposit. He shall deposit the balance amount along with 18% GST on the bid amount within seven days of the deposit of the initial amount. In case, he fails to make deposit of the total amount as per the tender within the stipulated time the deposit including the earnest money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment of tender value in time.
5. The successful bidder shall take permission and remove the vehicle from office premises of Deputy Director, Coffee Development, Koraput within seven days from deposit of the bid amount along-with receipt copy of 18% GST

deposit over the total bid amount in own GST number. If failed to remove the vehicle within aforesaid time span, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid place. If the ground rent so charged, exceed the sale price deposit, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall adjusted towards ground rent.
