7. The Bid received online shall open at **11:00AM** dtd' **17.10.2022** in the office of the Divisional Forest Officer, Koraput Forest Division in the present of the Bidders who wish to attend. Bidders who participated in the bid can be witness the opening of bids after logging on to the site through they are DSC. If the office happens to be closed on the last date of sell and receipt of the bids and specified, the bids will be opened the next working day at the same time and venue.
8. The cost of bid documents in shape of demand draft/ Bankers cheque issued from postal pledged and any Nationalized commercial Bank may be prepared in the name of the Divisional Forest Officer, Koraput Forest Division, Koraput mentioned under column No.7 above payable of Koraput separately i.e. towards paper cost for each Bid respectively.
9. Additional Performance Security shall be often from the Bidder when the Bid amount less then estimated cost put to tender. In such an event only the successful Bidder who has quoted less Bid price rates then the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand draft / Term Deposit received pledged in favour of the Divisional Forest Officer, Koraput Forest Division within seven days otherwise the Bid shall be canceled and the security deposit shall be forfeited. Further proceeding for black listing shall be initiated against the Bidder.
10. The bidder shall have to furnish a bid security declaration as per the Finance Department, Government of Odisha in lieu of Bid Security in the format annexed form of Bid security Declaration along with the bid.
