**Terms & Conditions of Hiring Vehicles:**

The following terms & conditions must be fulfilled by the successful bidder to provide vehicle on daily rent basis on demand (as and when required)

1. The hired vehicles provided on demand should **not have older than five years from the date of registration**, during period of contract, all necessarily valid MV documents such as: Valid Registration Certificate, Insurance Certificate, fitness Certificate, Valid Contract carriage permit, up to date tax payment etc. and D.L of the driver shall be available all the times.
2. The department/Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any property on account of use of hired vehicle any manner whatsoever. The vehicle owner/bidder shall be held responsible for all such litigation.
3. The hire charges and DOL consumed to be paid after submission of bill. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating engine oil etc will be borne by the bidder.
4. It shall be responsibility of the bidder to provide a good driver and the salary/wages of the driver shall be borne by the owner.
5. In case of break down for reasons whatsoever the replacement of the same or better model shall be provided by the owner of the vehicle on the day of requirement.


