07. The Successful Bidder should deposit the Additional Performance Security [if any](i.e. Amount Put to Tender minus the Quoted Amount) in shape of Term Deposit Receipt of any Nationalized/Schedule Banks/ Postal Pass Book/ National Savings Certificate pledged in favour of Project Administrator, I.T.D.A. Jeypore or Demand Draft in favour of Project Administrator, I.T.D.A. Jeypore payable at Jeypore within 07(Seven) Days from the receipt of the intimation letter in pursuance to the **Works Department Memorandum No. 07556900052021-4559/W, Dated.05.04.2021**. Failing which to deposit the required APSD amount within the stipulated time period, the bid document of the successful bidder liable for rejection and action will be initiate for Black listing in pursuance to Works Department Memorandum No.07556900042016-14402/W, Dated.06.10.2017.
08. For contracts with stipulated completion period exceeding six months and up to 12 months period, the rates and prices quoted by the bidder shall be fixed and the Government will not entertain any claim towards escalation of rates.
09. The Project Administrator, I.T.D.A. Jeypore is the Authority reserves the right, even if qualifying criteria are met, the bidders can be disqualified for the following reasons i.e. (i) Past Record of Poor Performance (ii) Past Record of abandoning the work half way/ recession of contract (iii) Past Record of in-ordinate delay in start/completion of the work.
10. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or III.
11. Since the works are time bound programme, the successful tenderer have to furnish a declaration at the time of agreement to complete the work within the stipulated time period of stages of completion specified in Col. 04 of the above mentioned table. Those who are unable to complete the work within the time, action will be taken as per codal provision laid under OPWD Code as well as amendment of Notifications of Works Department, Odisha from time to time.






