INVITATION FOR BIDS (IFB)

The Block Development Officer, Pottangi District- Koraput on behalf of Government of Odisha invites **Percentage Rate Bids** in double cover system in **online mode** in conformity with Detail Tender Call Notice to be eventually drawn up in State P.W.D Form F-2 contract for the execution of 05 Nos. of works as detailed in the table from the class of eligible contractors as mentioned against each work in Column No. 7 (Seven) registered with the State Governments and Contractors of equivalent Grade/ Class registered with Central Government/ MES/ Railways/ CPWD. The proof of valid registration from the appropriate authority shall be enclosed along with the tender. If successful, the bidder who has not registered under State Government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work as per prevalent registration norms of the state. The bidders may submit bids for the following works.

TERMS AND CONDITIONS: -

1. The details of work including the estimated cost, tender value, bid security/EMD, cost of bid documents, required class of contractor, completion time etc. are available in the e-procurement portal/website <https://www.tendersodisha.gov.in>.
2. Bid documents will be available in the e-procurement portal/website <https://www.tendersodisha.gov.in> from **Dt. 19.10.2023 to Dt. 03.11.2023** up to 05:00 P.M. for online bidding.
3. Bid documents for the individual work may be obtained from the e-procurement portal/website <https://www.tendersodisha.gov.in>.
4. Bids shall be received through "Online" mode only from **Dt. 19.10.2023 to Dt. 03.11.2023** up to 05:00 P.M.
5. Bid must be accompanied by **Bid security/EMD** on the amount specified for each work in column No. 5 (Five) of the above table as a part of its Bid through online.
6. The **cost of bid documents** mentioned under column No. 6 (Six) for each works is to be remitted through online.
7. Bidders must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
8. Bids received through "online" mode will be opened on **Dt. 04.11.2023 at 11:30 A.M.** in the office chamber of Block Development Officer, Pottangi in presence of the bidders or their authorized representatives having written authorization for the purpose.
9. **All documents should be self-attested.**
10. The following documents should be furnished by the bidders along with the Bid documents failing which the Bid/tender is liable for rejection.
 - a) Supportive document for the **cost of bid documents**.
 - b) **Bid security/EMD** duly pledged in favour of the Block Development Officer, Pottangi.
 - c) Self-attested copy of **Valid Contractor's Registration Certificate**.
 - d) Self-attested copy of **PAN Card, IT Return, Valid GST Registration Certificate & GSTIN and latest GST Return**.
 - e) **No Relation Certificate** should be furnished.
 - f) **Work Experience Certificate** should be furnished.
 - g) An **affidavit** in legal stamp in support of the authenticity of the documents.
 - h) **SC/ST** contractors desirous of availing price preference over General category contractors should submit an **affidavit in support of Caste certificate**.
 - i) The **Engineering Contractor** desirous of availing exemption of EMD should submit an **affidavit** to the effect that he has not availed exemption of EMD facility more than three times in the current financial year.

11. **Additional Performance Security** shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rate than the estimated cost put to tender shall have to furnish the exact amount as per table below. Additional Performance Security (APS) has to be furnished in shape of Demand Draft/ Term Deposit Receipt pledged in favour of the Block Development Officer, Pottangi within 7(Seven) days of issue of letter of acceptance (L.O.A.), otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further proceeding for black listing shall be initiated against bidder.

12. If any bidder quotes less than 15% (Fifteen) of the amount put to tender then such bid shall be rejected and the tender shall be finalized basing on merit of the rest bids and if more than one bid is quoted at 14.99% (decimal up to 2 Nos. will be taken for all practice purpose) less than the estimated cost, the tender accepting authority will finalize the tender through transparent lottery system in presence of bidder or their representatives.
13. **Scheduled Caste and Scheduled Tribe** bidders/tenderers will be given concession where their tenders are within 10 % of the rate quoted by the lowest tenderer for any work, the work may be considered for award to him/them at the lowest tendered rate. The Security deposit at half the usual rate may be deposited/ realized by/from the Scheduled Caste or Scheduled Tribe contractors coming under categories up to "B" class only as against the permissible percentage under Rule 13 of the PWD Contractor's Regulations Rules.
14. The selected bidders must have to deposit 1% ISD of Agreement Value & APS (if any) at the time of agreement in shape of **Demand Draft** drawn in favour of **Block Development Officer, Pottangi**.
15. The **Bid security/EMD** amount is to be forfeited if the successful tenderer backs out/ refuses from the offer of acceptance of tender by the competent authority. **Bid security/EMD** shall also be forfeited if the bidder/tenderer withdraws his/her bid during the tender period.

18. Since the works are time bound programme, the tenderers have to complete the same within the specified time, failing which; penalty of 10% will be imposed as per OPWD code.
19. Provisions of OPWD code as well as instructions and guidelines of Govt. of Odisha are applicable.
20. The bidder/tenderer has to show their original documents (Valid Contractor's License, PAN card, IT Return, GSTIN, GST Reg. Certificate, GST Return, Caste Certificate in case of SC/ST contractor/ Engineering Contractor License (for Engineering Contractor) etc. at the time of opening of the tender papers.
21. The quoted percentage rate should be mentioned clearly in **figures and in words**.
22. The percentage quoted in the tender without mentioning excess or less shall be treated as excess.
23. Any addendum/ corrigendum/ cancellation of above tender will be published in the e-procurement portal/website <https://www.tendersodisha.gov.in>.
24. The authority reserves right to reject/cancel any or all the tenders without assigning any reason thereof.
