OFFICE ORDER


In pursuance of letter No. 364 dated:13.01.2023 of Govt. in ST & SC Development Department and this office advertisement published vide notification No.-973 dated 21.03.2023 , the following candidates who are in the panel of selection as per proceeding of the selection committee for hiring of Guest Teacher against the vacancy of MCT are hereby engaged as **Guest Teacher** and posted to the school as mentioned against each until joining of regular teacher or attaining the age of 65 years whichever is earlier as per conditions detailed below with an honorarium of Rs.300/- (Rupees Three Hundred) per class and maximum up to Rs.12000/- (Twelve thousand) per month for 40 classes.

- I. The Guest teacher engaged would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of SSD Deptt.
- II. Working hours and period of duration shall be as per the school time table.
- III. The engagement of these Guest teachers will automatically come to an end once a regular/ contractual teacher is appointed/ engaged against the vacant post or as and when the appropriate authority decides.
- IV. The Guest Teacher so engaged shall also be entrusted with correction and evaluation work of the concerned subject in the school and he/she will not be entitled for extra honorarium for such work.
- V. The performance of the teacher will be reviewed on regular basis. If any teacher is found to be non-performing or engaged in activities leading to misconduct he /she shall be disengaged by the appropriate authority under intimation to District Welfare Officer.
- VI. A Guest Teacher unauthorized remaining absent and not taking classes for a continuous period of 15 days or more deemed to be terminated and he/she shall never be entertained further.
