- i. Interested candidates having the requisite qualification and experience may appear the Walk-in-Interview at Office of the Chief District Medical & Public Health Officer, At/Po- Koraput (Jail Road), Dist- Koraput, PIN-764020 on **05-09-2023**. Registration timing will be from **10.30 AM to 12 Noon** only on Walk-In-Interview date. No application will be received after scheduled timing of registration.
- ii. Candidates are required to submit filled in application in prescribed format available in the official website : www.koraput.nic.in and attach a set of self attested photocopies of the certificates/documents in support of age, qualification and experience, Internship Completion Certificate, Residence, Caste Certificates, two recent passport size colour photographs and self photo ID proof (Voter ID card / PAN card / Driving License /Aadhar Card /Passport). Incomplete application in any form will be rejected. No further supplementation, addition of document for any submitted application will be entertained.
- iii. **Age Relaxation and Additional Weightage of Marks for the applicants who are employees of the OSH&FW Society :**
 - a. To avail the benefit of age relation and weightage, employees concerned should have completed at least three terms of contractual services (11 months each) under the OSH&FW Society.
 - b. The remarks recorded in PAR of the employee concerned must be "Outstanding" or "Very Good" for the preceding 03 (three) terms of contractual services under the OSH&FW Society.
 - c. The age relaxation for the applied post in respect of the employees of the OSH&FW Society shall be allowed @ 1 year for each contractual term of service in the Society up to a maximum of 10 years, over and above the maximum age limit prescribed in the Advertisement for the said post, subject to an age ceiling of 55 years.
 - d. Candidates who is an employee of the OSH&FW Society and has cleared all the steps in the recruitment process upto the final level of selection shall be eligible for award of grace marks to the extent of 01 percentage of the total marks of examinations for each completed terms of services upto a maximum of 10 percentage of the total marks which shall be added to the total marks secured by the said employee.
 - e. All the above provisions shall also be applicable for only one member of the family of a deceased employee of the OSH&FW Society, if eligible, as would have been applicable to the employee concerned.
- iv. **Knowledge in Odia:** The candidate must-
 - a) be able to read, write and speak Odia;
 - b) have passed middle school examination with Odia as language subject; or
 - c) have passed Matriculation or equivalent examination with Odia as medium of examination in non-language subject; or
 - d) have passed in Odia as language subject in the final examination of class VII from a school or educational institution recognized by the Government of Odisha or the Central Government; or
 - e) have passed a test in Odia in Middle English School standard conducted by the School and Mass Education Department.
 - f) Must be above 21 years
- v. In case the marks obtained are in the form of CGPA, OGPA, DGPA, GPA, CPI etc., a certificate for conversion as applicable to percentage of marks shall be submitted at the time of submission of application form. Certificate towards AICTE recognition of institutions shall also be submitted at the time of submission of application form, wherever applicable, without which the application shall not be considered & shall be rejected.
- vi. Over aged, under qualification and short of requisite percentage of marks in the prescribed educational qualification shall be rejected. Candidates will be selected on the basis of selection process as applicable. Only eligible candidates will be called for participation in the selection process.
