ELIGIBILITY CRITERIA AND SELECTION PROCEDURE FOR CONTRACTUAL ENGAGEMENT OF ENTOMOLOGIST, NCVBDCP & INSECT COLLECTOR, NCVBDCP UNDER NHM, ODISHA

Entomologist, NVBDCP

Qualification: - The candidate must have passed Post Graduate Degree in Zoology or Life Science from a recognized University / Institution with minimum 55% marks. For Life Science candidates, Zoology should be one of the subject at Degree Level.

Experience: - The candidate must have 2 years of post-qualification experience in Vector Borne Disease Control Programme under Public Health System.

Upper Age Limit: - Upto 40 Years.

Selection Procedure: - Application invitation (Written-75 marks and Viva voce-25 Mark)

A list of eligible applicants, fulfilling the eligibility criteria shall be prepared on the basis of percentage of marks secured in the qualifying education examination.

From amongst the eligible applicants of the said list, 5 times of the number of vacancies from the top of merit list shall be called for appearing Interview.

The Final merit list shall be prepared as per the marks secured by the candidates in the written and Viva voce only. The candidates securing 50% and more marks in written and Viva voce together shall be kept in the Final Panel Merit list with the validity of 01 year from the date of its approval.
