TERMS AND CONDITIONS


1. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the office of the undersigned during the office hours every day except on Sunday and public holiday till last date of receipt of tender papers interested bidders may obtain further information at the same address.
2. The amount put to tender as per column-3 above are excluding GST.
3. The Tender Paper can be obtained from the Block Office, Jeypore on payment of cost of the tender paper (non-refundable) in shape of Demand Draft of Rs.6000/- drawn in favour of **Block Development Officer, Jeypore**. The tender paper will be sold from **03/01/2024 to 18/01/2024** on working days only from 10.00 AM to 4.00 PM in the office of the Panchayat Samiti, Jeypore.
4. The sealed tender papers will be received on working days till **3.00 PM** of **18/01/2024**. The sealed tender papers should be submitted through **Registered Post** only addressed to the Block Development Officer, Jeypore and by no other means. On the top of the envelope it should be clearly written "**Tender Paper**" and "**Name of the project**" for which project the bidder wants to participate in tender.

5. The Cost of tender paper in shape of Bank Draft/Bankers cheque (drawn in any Nationalized Bank in favour of B.D O JEYPORE Payable at State Bank of India, Jeypore should be enclosed with the tender document in separate envelope mentioning cost of tender paper.
6. The undersigned will not be held responsible for any delay in postal services. The tender papers received through postal service will be opened at **11.00 AM on 19/01/2024** in presence of the Tender Committee and Contractors or their authorized representatives.
7. Bidders should furnish EMD in shape of NSC/KVP/Post Office Term deposit/Term Deposit Receipt of any Nationalized Bank duly pledged in favour of "**Block Development Officer, Jeypore** along with tender documents. The tender papers without required amount of EMD will not be considered & transfer or adjustment of EMD is also inadmissible.
8. The following documents should be furnished along with the tender papers failing which the tender will be liable for rejection.
  - \*EMD pledged in favour of Block Development Officer, Jeypore.
  - \*Original money receipt granted by BDO, Jeypore towards cost of tender paper.
  - \* Self attested copy of Contractor Registration certificate.
  - \* Self attested copy of PAN Card.
  - \* Self attested copy of GST Registration Certificate.
  - \* Self attested copy of GST Clearance certificate.
  - \* Self attested copy of Caste certificate for SC/ST contractor desirous of availing preference.
  - \* Original Affidavit of no relation certificate.
  - \* Original Affidavit about authentication of documents submitted.
  - \* Past performance certificate (if any).
9. The Engineering Contractor desirous of availing exemption of EMD should submit an Original affidavit to the effect that he has not availed exemption of EMD facility more than three times in the current financial year.
10. A bidder can submit only one tender paper for one project. Submission of more than one tender paper by a bidder for the same work is liable for rejection.
11. For tender quoting less rate from the amount put to tender, if his/her tender is considered to be accepted then the differential cost will be deposited by the contractor before agreement in shape of NSC/KVP/Bank TDR in favour of **Block Development Officer, Jeypore**.
12. Scheduled Caste and Schedule Tribe Tenders will be given concession where their tenders are within 10% of the rate quoted by the lowest tenderer, for any work may be considered for award to him/them at the lowest tendered rate. The security deposit at half the usual rate may be deposited/realized by/from the schedule caste or Schedule Tribe contractors coming under categories up to 'B' class only as against the permissible percentage under Rule 13 of the PVD contractor's regulations rules.

13. The tenderer who quote the tender below 15% (Fifteen percent) less rate from the amount put to tender, the tender paper will be rejected. If more than one BID is quoted at 14.99% less than the estimated cost, the tender accepting authority will finalized the tender through transparent lottery system in presence of the bidder or representative.
14. The technical and financial bid documents should be sealed separately super scribed as " TECHNICAL BID" & "FINANCIAL BID" both technical & financial bid envelops shall be sealed in a outer envelope and super scribed with the name of work & bid identification no.
15. The Percentage quoted in the tender without mentioning excess or less shall be treated as excess.
16. The agency bidding for the work put of this notice, shall have to mention percentage of excess/less (both in words & figure) over the amount put to tender required by him in the prescribed format at the end of the bill of quantity. In the event of discrepancies the words & figure, the percentage quoted in words will count.
17. Any addendum/corrigendum/ cancellation of above tender will be displayed in notice Board and published in the website (<http://www.koraput.nic.in>) only.
18. The authority deserves all and every rights to reject or cancel any or all tenders without assigning any reasons thereof.
