



The Sealed envelope containing to separate sealed envelopes each for Bid Annexure-A for Bide application and Annexure-B for Financial Bid should be super scribed with “Sealed Tender papers”.
2. Tender papers will be received from _____ to _____ (up to 5.00PM) during office hours (except holidays) and will be opened on dated _____ at 5.30PM in the presence of the tender finalization committee members and bidders or their authorized representatives for finalization of Bids.
3. Bank Draft/Demand Draft of Rs.200/- (Rupees two hundred) only non-refundable is to be submitted by the Bidder drawn at any Nationalized Bank, in favour of Collector & DM, Koraput towards cost of Tender paper.
4. Earnest money deposit EMD of Rs. 5,000/- (Rupees Five thousand) only is to be submitted by in safe of Bank Draft/Demand Draft drawn at any nationalized Bank infamous of the **Collector & DM, Koraput**(Refundable). No exemption certificate will be accepted.
5. **Packing and supply of Items:** Items shall be packed in sealed packed as per the Indent to be supplied by the DCPU, Koraput for delivery of Items.
6. **Performance:** the cultural troupe perform their street play in local language with entertainment.
7. **Cost:** the bidder shall quote the rate of Items including transportation cost.
