01. That, I am the deponent and hence well acquainted with the facts of this affidavit.

02. That one Sri Chaitanya Hantal has filed his nomination paper as an Independent Candidate for Pottangi Constituency. He has obtained a false caste ST Certificate from the Tahsildar, Machhkund vide Misc. Certificate No.E-STO/2022/546680, dated: 05.09.2022. During past Sarapanch/Samiti Member Election, he had submitted his Caste (SC) Certificate. The BJP party has already issued the party ticket but due to the caste status issue the party has not provided the ticket. However it came to light that he has obtained a false Caste (ST) Certificate recently from the Tahsildar, Machhkund bearing Misc. Certificate No.E-STO/2024/57315, dated: 01.03.2024. Actually he belongs to Scheduled Caste Community but not belongs to ST Community. Basing on the false caste certificate issued in favour of Chaitanya Hantal, a news has been published in the Odia daily Newspaper The Samaj on dated: 25.04.2024, the copy of which is annexed herewith for your kind perusal and record. Though the Tahsildar Machhkund pretty well known that earlier the Caste Certificate bearing No.E-STO/2022/546680 issued in favour of Chaitanya Hantal has been cancelled, but however he has issued a fresh Caste (ST) Certificate in his favour bearing No.E-STO/2024/57315, dated: 01.03.2024. It is pertinent to mention here that his entire family members belongs to SC Community and the ST Caste Certificates of all the family members have been cancelled by the then Tahsildar.
